AN ORDINANCE ANNEXING LAND TO THE CITY OF WHITE BEAR LAKE, & MINNESOTA WHICH IS COMPLETELY SURROUNDED BY LAND WITHIN THE MUNICIPAL LIMITS

WHEREAS, the land hereinafter described is not included within the boundaries of any incorporated municipality, and

WHEREAS, said land is completely surrounded by land within the municipal boundaries of the City of White Bear Lake and is deemed to be urban in character, and

WHEREAS, the City Council feels that such annexation will be to the best interest of the City of White Bear Lake and of the affected territory.

NOW, THEREFORE, the Council of the City of White Bear Lake, Minnesota, does ordain:

1: That the following described land situated in Ramsey County, Minnesota, to-wit:

Lots 7, 8 and 9, Auditor's Subdivision No. 83 in the NOrtheast $\frac{1}{2}$ of Section 15-30-22, except the South 264 feet of the West 100 feet of said Lot 8.

be and the same is hereby annexed to the City of White Bear Lake, Minnesota.

2. That this Ordinance shall take effect and the annexation shall be deemed final after its passage, approval and publication and after a copy of such is filed with the Minnesota Municipal Commission, Ramsey County Auditor, Secretary of State of the State of Minnesota and Clerk of the Town of White Bear.


