

## AN ORDINANCE ANNEXING LAND TO THE CITY OF WHITE BEAR LAKE, MINNESOTA

WHEREAS, the owners of all of the land hereinafter described, which is unplatted and does not exceed 200 acres, have petitioned to the City Council of the City of White Bear Lake, Minnesota, to have said land annexed to the City of White Bear Lake, Minnesota; and

WHEREAS, a copy of said Petition was filed with the required governmental units and the Minnesota Municipal Commission; and

WHEREAS, no written objections to such annexation have been submitted to the Minnesota Municipal Commission or the City of White Bear Lake, said right to notice of said proceedings, and right to object thereto, having been waived; and

WHEREAS, the City Council feels that such annexation will be to the best interest of the City of White Bear Lake and of the territory affected;

NOW, THEREFORE, the Council of the City of White Bear Lake, Minnesota, does ordain:

1. That the following described land situated in Ramsey County Minnesota, to-wit:

The West thirty (W.30) acres of the South one half ( $S\frac{1}{2}$ ) of the Southeast one-quarter ( $SE\frac{1}{4}$ ) Section thirty-six (36), Township thirty (30), Range twenty-two (22), subject to public roads.

Excepting therefrom the following, to-wit:

All that part of the W. 30 acres of the  $S\frac{1}{2}$  of the  $SE\frac{1}{4}$  of Sec. 36, T 30, R 22 which lies W<sup>1</sup>ly and SW<sup>1</sup>ly of a line run parallel with and distant 50 feet E;ly and NE;ly of the following described line: From a point on the N. and S.  $\frac{1}{4}$  line of said Sec. 36, Distant 389.86 feet N. of the S.  $\frac{1}{4}$  corner thereof, run S;ly along said N. and S  $\frac{1}{4}$  line for 100 feet to the point of beginning of the line to be described; thence deflect to the left on a curve having a radius of 250 feet (delta angle  $81^{\circ}05'$ ) for 353.79 feet; thence on a tangent to said curve for 220.36 feet and there terminating; together with all that part of the above described tract adjoining and E<sup>1</sup>ly of the above described strip, which lies SW<sup>1</sup>ly of the following described line: From a point on the above described line, distant 100 feet NW<sup>1</sup>ly of its point of termination, run SE<sup>1</sup>ly along said line for 100 feet; thence deflect to the left on a  $6^{\circ}00'$  curve (delta angle  $8^{\circ}38'15''$ ) for 143.96 feet; thence deflect to the left at an angle of  $90^{\circ}$  with the tangent of said curve and run N<sup>1</sup>ly to an intersection with the N. line of County Road "D" which is the point of beginning of the line to be described; thence run NW<sup>1</sup>ly to a point distant 50 feet NE<sup>1</sup>ly (measured at right angles) from the point of termination of the above described line and there terminating;

containing 0.79 acres, more or less, in addition to the existing highways; together with all right of access, being the right of ingress to and egress from all that portion of the above described tract, not acquired herein, to Trunk Highway No. 694, except that the abutting owner shall retain the right of access to an outer lane only

be and the same is hereby annexed to the City of White Bear Lake, Minnesota.

2. That upon the effective date of this Ordinance such land shall become a part of said City as if it has been originally a part thereof.

3. This Ordinance shall take effect and the annexation shall be deemed final after its passage, approval and publication and after copy of such is filed with the Ramsey County Auditor, Secretary of and for the State of Minnesota, and the Minnesota Municipal Commission.
