AM ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF STAPLES AND INCORPORATING ADDITIONAL TERRITORY THEREIN

The City Council of the City of Staples do ordein as follows:

Section 1. A petition has been filed with the governing body of the Ulty of Evaples. Minneacta by the owner of the following described tract of real estate to have such trace included within the City of Staples. Minnesota:

The Northeast Quarter of the Southeast Quarter of Section 1, Township 133, Range 33 West of the 5th P. M., excepting and reserving therefrom the following tract, to-wit: Commencing at the northwest corner of NEM of SEM of Section 1, thence running east 375 feet, thence running south 30 degrees, 3 minutes west 600 feet to a point on the west line of said NEM of SEM of Section 1, Township 133, Range 33, 707 feet south of the point of beginning, thence/707 feet to the point of beginning and excepting and reserving therefrom the following tract, to-wit:

Commencing at the southwest corner of said NEM of SEM of Section 1, thence north 620 feet, thence east 33 feet, thence south 620 feet, thence west 33 feet to the point of beginning (the tracts hereby reserved are the same tracts reserved in that certain deed dated April 20, 1920 and recorded on June 4, 1920 in Bock 87 of Deeds, page 205) and excepting and reserving therefrom the following tract, to-with Commencing at a point on the south line of and NEM of SEM of Section 1, Theree training east on said south line 167 feet, thence running north and parallel to west line of said NEM of SEM of Section 1, 180 feet, thence running west 167 feet, thence south and parallel to the west line of NEM of SEM of Section 1, 180 feet to the point of beginning.

Notice of amenation has been served and filed at least thirty (30) days prior to the first reading of the ordinance....t

Section 2. The quantity of land embraced within the foregoing described parcel and bounded as described is approximately 35.5 acres.

Section 3. Notice of the filing of the petition has been filed with the Staples Town Board. County Auditor of Todd County and with the Minnesota Municipal Commission at least 30 days prior to the first meading of this ordinance.

Section 4. All fees required to be paid by the petitioner have been duly paid.

Section 5. The City Council hereby determines that the annexation will be to the best interests of the City of Staples, Minnesota, and of the territory affected; that the territory described herein abuts upon the City and is so conditioned as properly to be subject to City Government.

Section 6. Therefore, the City of Staples, Minnesota hereby ordains and declares that the property hereinbefore described be and the same is hereby annexed to, and included in, the City of Staples, Minnesota, as effectually as if it had originally been a part thereof.

Section 7. This ordinance shall be final and shall take effect and be in force from and after filing certified copy thereof with the Minnesota Municipal Commission, the County Auditor and the Secretary of State, and from and after its passage and publication.
