

Ordinance No. 58

AN ORDINANCE ANNEXING
CERTAIN TERRITORY TO
THE VILLAGE OF RAY-
MOND AND DECLARING
SAME TO BE AN ADDITION
TO THE VILLAGE OF RAY-
MOND:

Whereas, Irvin Holtz and wife Irene Holtz, Edna Wenzel and Amelia Wenzel, have heretofore presented to the Village Council of the Village of Raymond, Minnesota a petition, duly verified, that they are the sole owners of the Real Estate hereinafter described; that the said Real Estate abuts on and is adjacent the present boundry line of the corporate limits of the Village of Raymond, and praying that said Real Estate be annexed to the Village of Raymond.

Whereas no objections to the Annexation have been received from the Town Board or the County Board, the Village Council determines that said Annexation is of best interest of the Village and the territory affected.

Now, Therefore, Be it ordained by the Council of the Village of Raymond:

That all the certain pieces or parcels of land situated in the County of Kandiyohi and the State of Minnesota and described as follows, to-wit:

All that part of the NW $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 19, Township 118, Range 36, described as follows: Beginning at the Southwest corner of Lot 1, HOLTZ'S ADDITION, as of public record; thence NORTH, along the West line of said Lot 1, a distance of 140.00 feet to the Northwest corner of said Lot 1; thence NORTH, 50.00 feet to the North line of said NW $\frac{1}{4}$ of the SE $\frac{1}{4}$; thence WEST, along the last said line, a distance of 353.70 feet; thence S 2° 38' W, 190.20 feet; thence EAST, 362.44 feet to the point of beginning. Containing 1.59 acres, more or less.

This ordinance shall be in effect on and from its publication.
