An Ordinance Extending The Corporate Limits Of The City Of Albert Lea To Include Certain Unincorporated Territory Completely Surrounded by Land Within the City Limits

Introduced by Councilman Richard Michaelis

WEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, village, or borough; and

WHEREAS, this territory is completely surrounded on all sides by lands already included within the corporate limits of the City of Albert Lea and 1s deemed to be urban in character;

THE CITY OF ALBERT LEA DOES ORDAIN:

Sec. 1. <u>Territory Annexed</u>. The corporate limits of the City of Albert Lea, Minnesota, are hereby extended to include the unplatted territory described as follows, which territory now is and has heretofore been completely surrounded by territory already included with the city limits:

Beginning at a point on the east line of the NE½ SW½ of Section 33T - 103N - R21W, which point is 2020.65 feet north of the south ½ corner of said Section 33.

thence west 990.8 feet at an angle of 89°31.5', measured to the left from the east line of the NE& SW& of sd section, to the point of beginning of the parcel to be described;

thence north 792.92 feet at a deflection angle of 89°32.5' right to the centerline of the Airport Road;

thence west 344.8 feet at a deflection angle of 89°29' left along the centerline of the Airport Road to a point which is 16.5 feet west of the west line of the SE½ NW% of said Section 33;

thence south 162.94 feet at a deflection angle of  $90^{\circ}31^{\circ}$  left on a line parallel to and 16.5 feet west of the west line of the SE½ NW½ of said Section 33 to a point on the E & W ½ section line of said Section 33;

thence east 16.5 feet at a deflection angle of  $90^{\circ}21^{\circ}$  left on the E & W ½ section line of said Section 33 to a point on the west line of the SE½ NW½ of said Section 33;

thence south 630.32 feet at a deflection angle of 89°31' right along the west line of the SE½ NW½ of sd Section 33 to a point on the north line of Pilot Street (originally the Old Airport Road)

thence east 328.3 feet at a deflection angle of 89°32.5' along the north line of said Pilot Street to the point of beginning of the said parcel to be described;

except for the south 120 feet of the above described parcel; being part of the SW2 NW2, SE2 NW2 and NE2 SW2 of Section 33-T103N-R21W the above described parcel contains 5.13 acres.

Sec. 2. That the above property is hereby zoned C-2, General Commercial District except the south 240 feet thereof which is hereby zoned R-3, Multiple Dwelling District.

Sec. 3. <u>Filing</u>. The City Clerk is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the county in which the property is located, and the Minnesota Municipal Commission.


Sec. 4. <u>Effective Date of Annexation</u>. This ordinance takes effect upon passage and publication and the filing of certified copies as directed in Section 3.
