ORDINANCE NO. 501

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MARSHALL TO INCLUDE CERTAIN TRACTS OR PARCELS OF LAND WHICH ARE BORDERED AT LEAST 60% BY THE MUNICIPALITY.

The Common Council of the City of Marshall do ordain as follows:

Section 1. The Common Council of the City of Marshall hereby determines and finds that the perimeter of the tract or parcel of land hereinafter described is bordered more than 60% by the City of Marshall, that the same is urban in character and is so conditioned as properly to be subject to city government.

Section 2. The corporate limits of said City are hereby extended to include the tract or parcel of land described as follows and the same is hereby annexed to and included within the City as effectually as if it had been originally a part thereof;

The North 689.6 feet of the South 1735.3 feet of the Southwest Quarter of Section 33, Township 112 North, Range 41 West, lying westerly of the Burlington-Northern Railroad right-of-way, containing 21.22 acres more or less.

Section 3. This ordinance shall be final and shall take effect and be in force from and after filing certified copy thereof with the Minnesota Municipal Commission, the Town Clerk of Fairview Township, the County Auditor of Lyon County and the Secretary of State and from and after its passage and publication.

Passed and adopted this 18th day of December, 1972.
