AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF
THE CITY OF MANKATO TO INCLUDE CERTAIN UN-
INCORPORATED PLATTED TERRITORY NOT EXCEEDING
200 ACRES, 60% OR MORE OF WHICH IS BORDERED BY
PROPERTY WITHIN THE CITY

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, village, or borough; and,

WHEREAS, this territory, is completely surrounded on all sides by lands already included within the corporate limits of the City does not exceed 200 acres, and is deemed to be urban in character;

THE CITY OF MANKATO, MINNESOTA, DOES ORDAIN:

1. That the annexation will be to the best interest of the City and of the land affected;
2. That the land described herein abuts upon the City Limits and is urban in character; and
3. That none of said land is now included within the limits of any city, village, or borough;

NOW THEREFORE BE IT RESOLVED by the Council of the City of Mankato that the corporate limits of the City are hereby extended to include the platted land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been part thereof:

The East Half ($E\frac{1}{2}$) of the Northwest Quarter ($NW\frac{1}{4}$) of Section 16, Township 108 North, Range 26 West excepting therefrom the South 810 feet of the East Half ($E\frac{1}{2}$) of the Northwest Quarter ($NW\frac{1}{4}$) of Section 16, Township 108 North, Range 26 West.
(containing 53.50 acres more or less)

The City Clerk is hereby directed to file certified copies of the Ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

This Ordinance shall take effect ten days after the date of its passage and publication.
