I indicated that it was the intent of the City Council to commence annexation action on March 1, 1973.


No objection to this annexation has been received from any of the governmental agencies so notified.

1.39 AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE CITY OF PIPESTONE

The City Council of the City of Pipestone do ordain as follows:

Section 1. A tract of land described by notes and bounds as follows:

Commencing at a point 2035 feet West of the southeast corner of Section 11, Township 106, Range 46; running thence West on the South line of said Section 11, a distance of 605 feet, to the North-South Quarter line; thence North 909.21 feet; thence East 605 feet; thence South 909.21 feet to the point of beginning, containing 12.62 acres; now owned by Independent School District #583, being contiguous to and abutting on the corporate limits of said city, is hereby declared to be a part of the City of Pipestone.

Section 2. This property is a part of the 40 acre school athletic complex.

Section 3. This ordinance shall take effect and be in force from and after its passage and publication.
