AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO INCLUDE CERTAIN PLATTED LAND NOT EXCEEDING 200 ACRES ABUTTING THE CITY LIMITS.

WHEREAS, a Patition was filed requesting the annexation of the territory hereinafter described, which Patition was duly presented to the Common Council on the 7th day of August, 1972, and

WHEREAS, the quantity of lands embraced within the area described in the Fetition and bounded as described is 28 seres of platted land, no part of which is included within the limits of an incorporated city, village or borough, and

WHEREAS, the Patition was algred by a majority of the owners, and

WHEREAS, a hearing was held on the proposed ennexation as required by M. S. A. 414.033 Subd. 5, and no objections to the annexation have been received from the Town Board, the County Board or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be ennexed; and

WHEREAS, the land described in the Patition abute upon the City of Austin at the North boundary thereof;

THE COMMON COUNCIL OF THE CITY OF AUSTIN DO ORDAIN:

SECTION I) The City Council hereby determines. 1) that the amenation will be to the best interects of the City and of the territory affected. 2) that the territory described herein abute the city limits, and is about to become urban or suburban in character, and 3) that nome of said territory is now included within the limits of any city, village or berough.

SECTION 2) The corporate limit of the City of Austin are hereby extended to include the platted land described as follows, and the same is hereby amazed to and included within the City of Austin as effectually as if it had originally been a part thereof:

Deginning of the S.E. corner of the S.W. 4 of Section 27, Township 103 North Range 18 West Mower County, Minnesota: thence Northerly on said quarter line a distance of 1199.1 feet to a point that intercects the North Line of Elmhurst Addition extended Ecotorly; thence Westerly along the North line of Elmhuret Addition to the West line of soid addition; thence Southerly along the West line of sold addition until it intersects the South line of said addition. This point also being on the South Line of said & Section; thence Easterly along the South Line of said addition until it intersects the S. E. corner of the S. W. 4 of sold section and the point of beginning, with the following exceptions: Lote 1, 2, 3, 4, and Lot A in Block 4 of Elmhurst Addition. Lot 10 except the North one foot thereof, Lots 11, 12, 13, 14, 15, and Lot 16 except the North 9.1 feet in Block 3 of soid addition plus Lots 5, 6, and 7 in block 4 of said addition plus Lots 1, 2, and 3 except the West 60 feet of Lots 1 and 2 in Block 5 of Elmhurst Addition to the Township of Laneing, Mover County, Minnesota.

SECTION 3) The City Recorder is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the Secretary of State, the County Auditor and the Township Clerk of Lansing Township.

SECTION 4) The Ordinance takes offert upon its passage and publication and filing of the certified copies as directed in Section 3.
