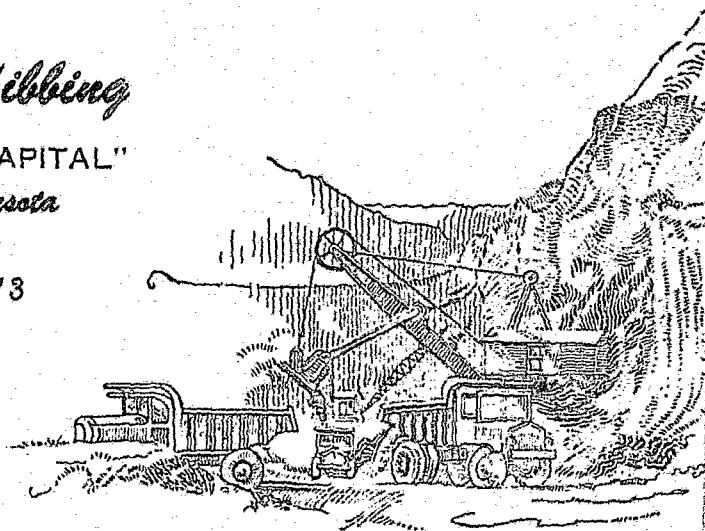

ORDINANCE NO. 278

AN ORDINANCE COMBINING THE OFFICE OF VILLAGE TREASURER FOR THE VILLAGE OF HIBBING AND THE OFFICE OF VILLAGE CLERK FOR THE VILLAGE OF HIBBING INTO THE SUCCESSOR OFFICE OF VILLAGE CLERK-TREASURER

WHEREAS, Minnesota Statutes 412.02, Subd. 3, empowers the Village Council to enact an ordinance combining the offices of Clerk and Treasurer into the office of Clerk-Treasurer, and

WHEREAS, the Village Council of the Village of Hibbing desires to combine the offices of Village Treasurer and Village Clerk into the combined successor office of Village Clerk-Treasurer,

NOW, THEREFORE, be it ordained by the Village Council of the Village of Hibbing, St. Louis County, Minnesota, as follows:

Section 1. The office of Village Treasurer for the Village of Hibbing, Minnesota and the office of Village Clerk for the Village of Hibbing are hereby combined into the single office of Village Clerk-Treasurer for the Village of Hibbing, Minnesota. The duties of the Village Treasurer and the Village Deputy Treasurer shall, from the effective date of this ordinance, be performed by the new officer to be known as the Village Clerk-Treasurer or his duly appointed deputy. The office previously known as the Village Clerk shall henceforth be known and referred to as the Village Clerk-Treasurer. The office previously known as Village Treasurer is, from the effective of this ordinance, abolished and abandoned.

Section 2. The effective date of this ordinance shall be the expiration of the term of the incumbent Village Treasurer or when an earlier vacancy occurs in the office of Village Treasurer, whichever occurs first.
