ORDINANCE NO. 2-1955

An Ordinance Adding and Annexing Certain Real Property to the Village of Paynesville in Stearns County, Minnesota.

The Village Council of the Village of Paynesville Does Hereby Ordain:

Section 1. That the following described real estate which abuts upon the incorporated Village of Paynesville, Stearns County, Minnesota, be and the same is, added and annexed to the Village of Paynesville, Stearns County, Minnesota and is hereby made a part of said Village to the same effect as if said Real Property had been originally a part thereof; all of said real property is situated in the County of Stearns and State of Minnesota and is described as follows:

All that part of the Easterly 165 feet of the Northwest quarter of the Southwest quarter except the Northerly 264 feet thereof, of section 16, Township 122 north, Range 32 west, which lies northerly of State Highway No. 55.

This ordinance shall take effect and be in force from and after its publication.
