ORDINANCE NO. 2097

Introduced by Councilman Richard Michaelis

An Ordinance Extending the Corporate Limits of the City of Albert Lea to Include Unincorporated Territory Bordered by Lands within the City Limits of Albert Lea and Abutting there-on

WHEREAS, certain territory described below is not presently included within the corporate limits of any Incorporated City, Village or Borough, and,

WHEREAS, 60% or more of the perimeter of this territory is bordered by lands already included within the corporate limits of the City, and is deemed to be urban in character, and,

WHEREAS, a notice of intent to annex the following property was served upon the Township of Bancroft as required by law and a period of more than 60 days has elapsed since such service, without the filing of written objections by the Town Board with the Minnesota Municipal Commission and the City of Albert Lea.

THE CITY OF ALBERT LEA DOES ORDAIN:

Sec. 1. The corporate limits of the City of Albert Lea are hereby extended to include platted and unplatetd territory as provided under MS. 414.033 Sub 3, described as follows, 60% of or more of the perimeter of which territory is bordered by territory already included within the City limits:

All of the NW $\frac{1}{4}$  NW $\frac{1}{4}$  Sec. 33-T103N-R21W exc the two parcels desc as follows: Beg at a pt 410° East of the NW Corner of sd Section 33; th west 410° on the north line of sd Sec. 33 to the NW Cor of sd Sec. 33; th south 1325.2° on the west line of sd Sec. 33 to the SW Corner of the NW $\frac{1}{4}$  NW $\frac{1}{4}$  of sd Sec. 33; th East 670° on the south line of the NW $\frac{1}{4}$  NW $\frac{1}{4}$  of sd Sec. 33; thence northwesterly to the point of beginning; and exc that portion of the NW $\frac{1}{4}$  NW $\frac{1}{4}$  of sd Sec. 33 desc as follows: Beginning at the SE Cor NW $\frac{1}{4}$  NW $\frac{1}{4}$  of sd Sec. 33; th west 437.40° on the south line of the NW $\frac{1}{4}$  NW $\frac{1}{4}$  of sd Sec. 33; th N6°14'E for a distance of 632.33' to a point on the east line of the NW $\frac{1}{4}$  NW $\frac{1}{4}$  of sd Sec. 33; th south 418.96' on the east line of the NW $\frac{1}{4}$  NW $\frac{1}{4}$  of sd Sec. 33 to the pob; being part of the NW $\frac{1}{4}$  NW $\frac{1}{4}$  of Sec. 33-T103N-R21W. The above described parcel containing 21.62 acres.

ALSO

Beginning at the SE Cor of the NW $\frac{1}{4}$  NW $\frac{1}{4}$  Sec. 33-T103N-R21W; th West 888.23° on the south line of the NW $\frac{1}{4}$  NW $\frac{1}{4}$  or an angle of 89°24.5° measured to the left from the north and south  $\frac{1}{4}$  section line of sd Sec 33 to a pt on the NW $\frac{1}{4}$  line of the Albert Lea Airport property; th northwesterly 1,227.92° at a deflection angle of 135°44.5° right on sd northwesterly line of sd airport property, to a pt on the north & south  $\frac{1}{4}$  Sec. line of sd Sec 33, th pt is on the centerline of CSAH 22; th south 857.07° at a deflection angle of 133°40' right on sd north & south  $\frac{1}{4}$  section line to the point of beginning; being part of the NW $\frac{1}{4}$  NW $\frac{1}{4}$  of Sec. 33, T103N-R21W and containing 8.74 acres.

Sec. 2. That the above property is hereby zoned: First parcel above described R-1; Second parcel above described C-2

Sec. 3. The City Clerk is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the County in which the property is located, and the Minnesota Municipal Commission.
