ENTRACT OF HINUTES OF METTING OF THE VILLAGE COUNCIL OF THE VILLAGE OF MORA, MINUESOTA

Pursuant to due call and notice thereof, a regular meeting of the Village Council of the Village of Mora, Minnesota, was held at the Village Hall in said Village on Tuesday, November 21, 1972, at 7:30 o'clock P.M., with the following members present: Mayor Anderson, Councilmen Harris, Kuchar, DeWitt and Nelson; and the following members absent: none.

The Council received a petition signed by a majority of the land owners requesting annexation to the Village of Mora. After due consideration, the motion was made, seconded, and unanimously passed to adopt the following resolution:

RESOLUTION ESTABLISHING A PUBLIC HEARING FOR CONSIDERATION OF ANNEXATION OF CERTAIN PROPERTY TO THE VILLAGE OF MORA, MINNESOTA

WHEREAS, a certain petition dated May Z. 1972, requesting that certain territory described therein be annexed to the Village of Mora. Minnesota, was duly presented to this Council on the Zist day of November, 1972; and

WHEREAS, said petition is signed by a majority but not by all the owners of the lands described therein; and

WHEREAS, no objections to the annexation have been received from the town board, the county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed;

BE IT RESOLVED By the Village of Mora, Minnesota;

1. A public hearing will be held at Mora on the 20th day of February, 1973, beginning at 7:00 P.M. to consider the matter of annexing the territory described as follows to the Village of Mora:

Northwest Quarter of the Southeast Quarter (NW+ of SE+) of Section Twelve (12), Township Thirty-nine (39), Range Twenty-four (24), Kanabee County, Minnesota

ALSO

West Half of the Southwest Quarter of the Southeast Quarter (Wg of SWt of SET). North of Railroad right-of way, Section Twelve (12), Township Thirty-nine (39), Range Twenty-four (24), Kanabee County, Minnesota.

2. The Clerk is hereby directed to give notice of such hearing in the manner provided by law.

EXTRACT OF MINUTES OF MESTING OF THE VILLAGE COUNCIL OF THE VILLAGE OF MORA, MINNESOTA

Pursuant to due call and notice thereof, a regular meeting of the Village Council of the Village of Mora, Minnesota, was held at the Village Hall in said Village on Tuesday, March 6, 1973, at 4:00 o'clock P.M., with the following members present: Mayor Anderson, Councilmen Harris, Kuchar, DeWitt and Nelson; and the following members absent: none.

The Council continued the annexation hearing from February 20, 1973, and after further consideration member DeWitt introduced the following Ordinance and moved its adoption:

ORDINANCE 107

AN ORDINANCE EXTENDING THE CORPORATED LIMITS OF THE VILLAGE OF MORA TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE VILLAGE LIMITS.

WHEREAS, a certain petition dated May 2, 1972, requesting annexation of the territory hereinafter described was duly presented to the Council on the 21st day of November, 1972; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 38 acros of unplatted land, no part of which is included within the limits of an incorporated city, village or borough; and

WHEREAS, the petition was signed by two (2) owners, constituting a majority but not all of a total number of three (3) owners; and

WHEREAS, no objections to the annexation have been received from the town board, the county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, a hearing was duly held by the governing body of the Village of Mora, Minnesota, on the proposed annexation after at least thirty (30) days mailed notice; and

WHEREAS, the land described in the petition about upon the village limits at the East boundary thereof:

The Council of the Village of Mora, Minnesota, ordains;

Section 1. The Village Council hereby determines
(1) that the annexation will be to the best interests of the Village and of the territory affected; (2) that the territory described herein abuts upon the Village limits and is about to become urban or suburban in character; and (3) that none of said territory is now included within the limits of any city. Village, or Borough.

Section 2. Territory Annexed. The corporate limits of the Village are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the Village as effectually as if it had originally been a part thereof:

Northwest Quarter of the Southeast Quarter (NW# of SE#) of Section Twelve (12), Township Thirty-nine (39), Range Twenty-four (24), Kanabec County, Minnesota

ALSO

West Half of the Southwest Quarter of the Southeast Quarter (W2 of SW2 of SE2). North of Railroad right-of-way. Section Twelve (12). Township Thirty-nine (39). Range Twenty-four (24). Kanabec County, Minnesota.

Section 3. Filing. The Village Clerk is hereby directed to file certified copies of this Ordinance with the Minnesote Municipal Commission, the Secretary of State, and the County Auditor.

Section 4. Effective Date. This Ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
