

ORDINANCE NO. 169

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF
THE VILLAGE OF CAMBRIDGE, ISANTI COUNTY, MINNESOTA,
TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING
200 ACRES IN AREA

WHEREAS, A certain Petition dated the 9th day of May, 1973,
requesting annexation of the territory described below, was duly
presented to the Council and filed in the office of the Village Clerk
on said date; and

WHEREAS, said Petition for Annexation was duly signed by all
of the owners of said property described below; and

WHEREAS a true and correct copy of said Petition for Annexation
was duly filed in the office of the Township Clerk of the Township of
Cambridge, with the County Board in and for Isanti County by filing the
same with the County Auditor, and with the Municipal Commission of the
State of Minnesota; and

WHEREAS the Township of Cambridge has waived any objections
and consented to the annexation of such territory, and

WHEREAS the Village Council has determined the annexation of
the territory hereinafter described will be to the best interest of
the municipality and to the territory affected, and that said territory
is so conditioned as properly to be subjected to village government:

NOW THEREFORE, THE VILLAGE COUNCIL OF CAMBRIDGE ORDAINS:

Section 1. Declaration. It is hereby determined that the
territory described below abuts upon the Village of Cambridge and is
so conditioned as to properly be subjected to Village Government, and
that the annexation thereof would be to the best interest of Cambridge
and the territory affected.

Section 2. Territory Annexed. The corporate limits of the
Village of Cambridge are hereby extended to include the territory
described as follows, to-wit:

That part of Lot 82, Auditor's Subdivision No. 8 in
Isanti County, Minnesota and Government Lots 3 and
4, Section 29, Township 36, Range 23 in Isanti County,
Minnesota, as follows:

Beginning at the Northeast corner of Lot 1, Block 1
of the plat of River Heights, Isanti County, Minnesota;
thence North and parallel to the East line of said Lot
82 a distance of 438.52 feet to the North line of said
Lot 82; thence South 89°56'02" West on the North line
of said Lot 82 and Government Lot 4 a distance of 657.03
feet; thence North 3°57'15" East a distance of 188.63
feet; thence North 41°07' West a distance of 225 feet,
more or less, to the Easterly shore line of the Rum River;
thence Southwesterly on said shore line to a point on a
line which bears North 3°57'15" East from a point on the
Westerly extension of the North line of said plat of River
Heights, said point being 885.79 feet West of said North-
east corner of Lot 1, Block 1 of said plat of River Heights;
thence South 3°57'15" West a distance of 743 feet more or
less to a point on the Westerly extension of the North line
of the plat of said River Heights; thence East on the North
line of said plat of River Heights and its Westerly
extension a distance of 885.79 feet to the point of
beginning. (but excepting that part thereof already within
the village boundaries).

Section 3, Filing. The Village Clerk is hereby directed to file certified copies of this ordinance in the office of the Secretary of State, in the office of the Minnesota Municipal Commission, in the office of the Township Clerk in and for Cambridge Township, and in the office of the Isanti County Auditor, all pursuant to Minnesota Statutes Section 414.03, as amended, and this annexation is final upon such filing.
