

ORDINANCE NO. 235

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF GLENCOE TO INCLUDE CERTAIN UNINCORPORATED PROPERTY ABUTTING UPON THE CORPORATE LIMITS OF SAID CITY

THE CITY COUNCIL OF THE CITY OF GLENCOE ORDAINS:

1. That the corporate limits of the City of Glencoe be and they hereby are extended to include the following described real estate, abutting on the corporate limits of said city, and described as follows to-wit:

Commencing at the East Quarter Corner of Section Thirteen, Township One Hundred Fifteen North Range Twenty-Eight West, thence Westerly on the Quarter Section Line on a bearing of South 89° 19'30" West for a distance of 1508.00 feet to the actual point of beginning, thence continuing on the Quarter Section Line Westerly on a bearing of South 89°19'30" West for a distance of 562.00 feet, thence on a bearing of South 00°40'30" East for a distance of 132.00 feet, thence on a bearing of South 89°19'30" West for a distance of 33.00 feet, thence on a bearing of South 03°40'30" West for a distance of 106.30 feet to a point on the North right-of-way line of proposed Trunk Highway 212, thence following the proposed right-of-way line on a bearing of South 86°41'30" East for a distance of 369.40 feet, thence following the proposed Trunk Highway 212 right-of-way line along a 2°00' tangential spiral curve to the left on a bearing of South 86°49'30" East for a chord distance of 92.85 feet, thence following the 2°00' tangential spiral curve to the left on a bearing of South 87°51'30" East for a chord distance of 37.80 feet, thence following the 2°00' tangential spiral curve to the left on a bearing of South 88°43'30" East for a chord distance of 62.00 feet, thence following a 2° tangential simple curve to the left on a bearing of North 88°47'30" East for a chord distance of 44.00 feet, thence on a bearing of North 00°59'30" West for a distance of 273.10 feet to the point of actual beginning, except Valley View Subdivision according to the plat thereof on file and of record in the Office of the Register of Deeds in and for said County.

2. This ordinance takes effect from and after its passage and publication.
