TERRITORY TO THE VILLAGE OF SPRING VALLEY,  
MINNESOTA.

ORDINANCE NO. 112

AN ORDINANCE ANNEXING TERRITORY TO THE VILLAGE OF SPRING VALLEY,  
MINNESOTA.

The Village Council of the Village of Spring Valley does hereby  
ordain as follows:

A Petition having been filed in accordance with the provisions of  
the Laws of the State of Minnesota, 1969, Chapter 1146, Section 12.  
It is hereby determined that the annexation of the following  
described property located in the County of Fillmore, State of  
Minnesota, to-wit:

Beginning at the center of said Section 28; thence  
West a distance of 320.5 feet; thence North a  
distance of 999.8 feet; thence North 33 degrees  
25 minutes West a distance of 356 feet; thence  
North 57 degrees 35 minutes East a distance of  
108 feet; thence South 36 degrees 55 minutes East  
a distance of 171 feet; thence North to the North  
Line of the Southeast Quarter of the Northwest  
Quarter of said Section 28; thence East to the Northeast  
Corner of the Southwest Quarter of the Northeast Quarter  
of said Section 28; thence South along the East line  
of the Southwest Quarter of the Northeast Quarter of  
said Section 28 a distance of 1096 feet; thence East  
a distance of 79 feet; thence South a distance of 220  
feet to the quarter line of said Section 28; thence  
west along said quarter line of said Section 28 a distance  
of 1467 feet, more or less, to the center of said Section  
28, which is the point of beginning, containing 47.4 acres,

is and will be for the best interest of the Village of Spring Valley  
and will be and is in the best interest of the territory affected by  
said annexation, and it is hereby declared that such land be annexed  
to the Village of Spring Valley, Minnesota.

This Ordinance shall be in full force and effect from and after the  
passage and publication as provided by law.
