ORDINANCE NO. 92

ORDINANCE ANNEXING CERTAIN LANDS

TO THE VILLAGE OF STEWARTVILLE

MEREAS, the lands described below is within the incorporated limits of the Village of Stewartville,

AND MEREAS, the land and improvements thereon is urban in character, is and has been receiving the benefits of Village services,

AND WHEREAS, the land is completely surrounded by Village lands, no Public Hearing is required,

AND WEREAS, the Village Council has determined that the annexation will be to the best interest of the Village of Stewartville and territory affected:

THE VILLAGE COUNCIL OF STEWARTVILLE, MINNESOTA, DOES ORDAIN:

1. The following described lands are hereto annexed and made a part of the Village of Stewartville, to-wit:

A parcel of land in the North west Quarter of the Southeas Quarter, Section 27, Township 105, Range 14, the north and west lines of said 20 acre square parcel of land are the east right-of-way lines of U.S. Highway #63 and the south right-of-way line of the Township Road lying north of said parcel. Said 20 acres of land were deferred from lands previously annexed to the Village by Ordinance #80 adopted the 8th day of June 1970.

2. The Village Clerk shall file a certified copy of this ordinance with the Minnesota Municipal Commission, County Auditor and the Secretary of State.

Adopted by the Council this 5th day of March 1973.
