ORDINANCE NO.

AN ORDINANCE DECLARING CERTAIN PLATTED AND UNPLATTED LAND IN ST. JAMES TOWNSHIP TO BE ANNEXED TO THE CITY OF ST. JAMES, MINNESOTA.

BE IT ORDAINED By the City of St. James, Minnesota, as follows:

- (1) The tracts of land lying adjacent to the City of St. James and being in the County of Watonwan and described on Exhibit A attached hereto are hereby annexed and declared to be a part of the City of St. James and to be included in the corporate limits thereof.
- (2) This Ordinance shall take effect from and after its date of passage and publication.

Parcel I. Alveretta M. Austrum Trust
