RESOLUTION
No. 7-128-73

At a regular meeting of the City Council held July 10, 1973 Alderman Rambeck, seconded by Alderman Narverud introduced the following resolution and moved its adoption:

ORDINANCE NO. 389
AN ORDINANCE ANNEXING CERTAIN LANDS
TO THE CITY OF THIEF RIVER FALLS.

The City Council of the City of Thief River Falls do hereby ordain as follows:

Section 1.

WHEREAS, all of the owners of the following described premises situated in the County of Pennington and State of Minnesota, to-wit:

A parcel of land which is part of the NW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 35, T. 154N., R. 43 W. bounded as follows:

Beginning at the Southeast corner of Lot 1 of Block 2, of Arthur's 2nd Addition to the City of Thief River Falls, Mn. thence South 87 deg. 01' 30" East a distance of 220.296' along the North line of Robin Hood Drive; thence due North to the North line of said Section 35, thence westerly along said North Line to a point due North of the East line of Arthur's 2nd Addition; thence due South along said East line of said Arthur's 2nd Addition to the point of beginning, containing 5.7 acres more or less,

have petitioned the City Council to have such land included within the municipality and have filed copies of said Petition with the Municipal Commission of the State of Minnesota, with the Town Board of the Township of North, and with the County Board of the County of Pennington, State of Minnesota, and

WHEREAS, the above described property abuts upon the boundaries of the City of Thief River Falls, and

WHEREAS, no objections to the proposed annexation have submitted,

NOW, THEREFORE, IT IS HEREBY DETERMINED that the annexation of said premises will be to the best interest of the City of Thief River Falls and of the territory affected and the above described premises are hereby declared annexed to the City of Thief River Falls.

Section 2.

This ordinance shall be in force and effect from and after its passage, approval, publication and filing with the Municipal Commission, Town Clerk, the Pennington County Auditor and the State of Minnesota Secretary of State.



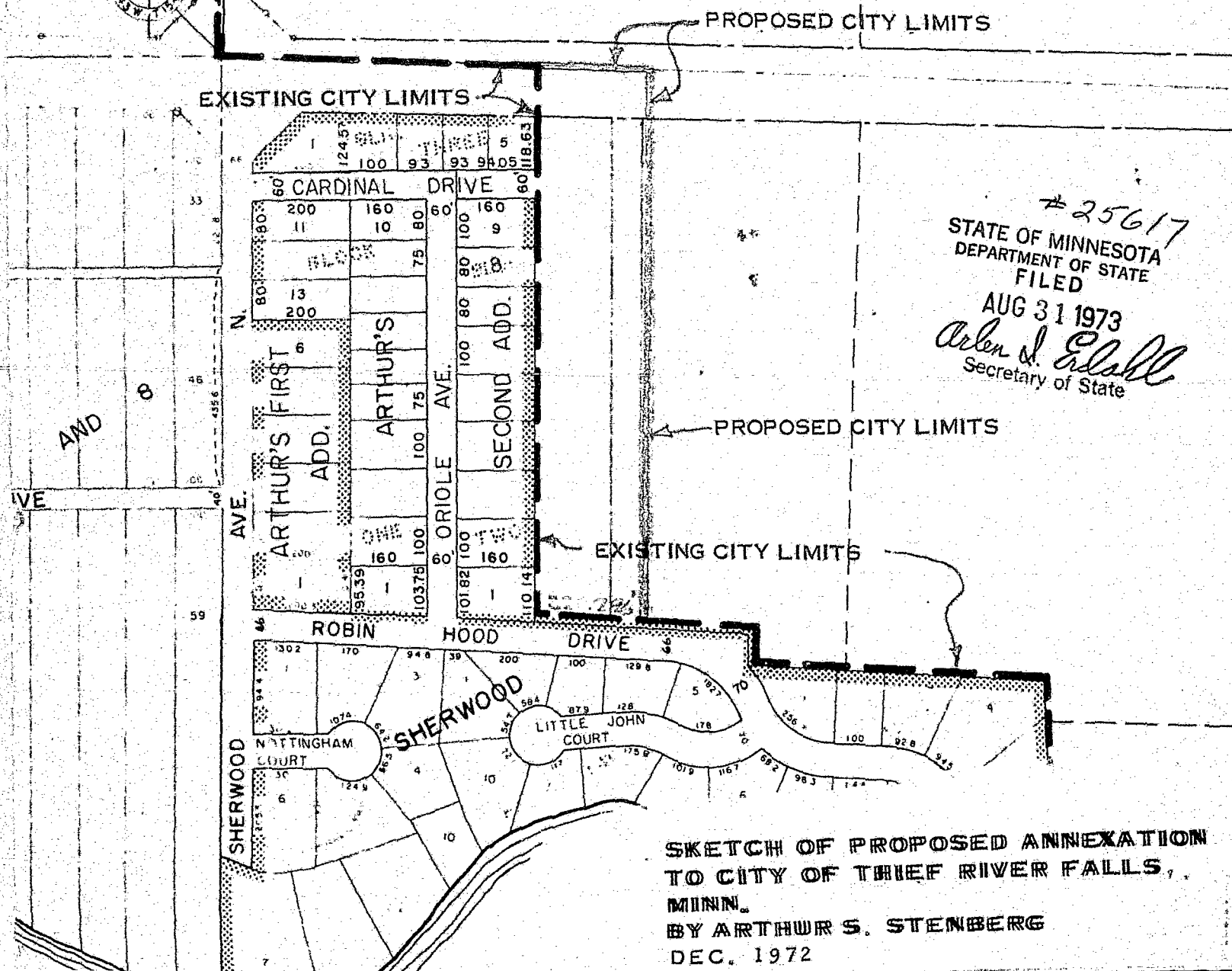
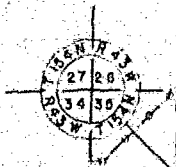
