ORDINANCE NO. 180

CITY OF NEW ULM, BROWN COUNTY, MINNESOTA

AN ORDINANCE EXTENDING THE BOUNDARY LINES OF THE CITY OF NEW ULM, MINNESOTA, AND ANNEXING CERTAIN LANDS THERETO PURSUANT TO MINNESOTA STATUTES, CHAPTER NO. 414.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NEW ULM:

WHEREAS, the City of New Ulm and a majority of owners of land herein described have filed and requested that certain lands and parcels of land be annexed to the City of New Ulm, the same not exceeding two hundred (200) acres in area, and

WHEREAS, appropriate copies of the petition have been filed with the Minnesota Municipal Commission, the Board of Commissioners of Brown County and Milford Township, and

WHEREAS, no objection to the annexation have been received from the Town Board or the County Board, and

WHEREAS, the City Council of the City of New Ulm has determined that the annexation of the land as petitioned for should be granted, and

WHEREAS, the City Council determined that the annexation will be in the best interests of the City of New Ulm and the territory affected; that the territory described herein abuts upon the City limits and is urban or suburban in character; that none of said territory is now included within the limits of any city, village or borough.

THEREFORE, the City Council of the City of New Ulm by this ordinance does ordain and decree:

Section 1. The corporate limits of the City of New Ulm are hereby extended to include the unplatted land described as follows, and the same is hereby annexed and included within the City as effectively as if it had originally been a part thereof:

- Parcel 1 - Sublot C-2 of Government Lot 8, Section 34, Township 110 North, Range 30 West, Brown County, Minnesota, containing 3.52 acres, more or less.
- Parcel 2 - Lot B of Outlot 486, City of New Ulm, Brown County, Minnesota, containing 3.0 acres, more or less.
- Parcel 3 - Balance of Sublot E of Government Lot 8, Section 34, Township 110 North, Range 30 West, Brown County, Minnesota, containing 4.47 acres, more or less.

- Parcel 4 - Sublot D of Government Lot 8, Section 34, Township 110 North, Range 30 West, Brown County, Minnesota, containing 5.14 acres, more or less,
- Parcel 5 - Lot 1 of the Southwest Quarter of the Southwest Quarter, Section 34, Township 110 North, Range 30 West, Brown County, Minnesota, containing 1.77 acres, more or less,
- Parcel 6 - Lot A of Government Lot 9, Section 34, Township 110 North, Range 30 West, Brown County, Minnesota, containing 4.18 acres, more or less,
- Parcel 7 - Lot B of Government Lot 9, Section 34, Township 110 North, Range 30 West, Brown County, Minnesota, containing 0.51 acre, more or less,
- Parcel 8 - Lot C of Government Lot 9, Section 34, Township 110 North, Range 30 West, Brown County, Minnesota, containing 12.56 acres, more or less,
- Parcel 9 - East 20 acres North of South 20 acres of Government Lot 9, Section 34, Township 110 North, Range 30 West, Brown County, Minnesota, containing 20 acres, more or less,
- Parcel 10 - Balance of the Southeast Quarter of the Southwest Quarter, Section 34, Township 110 North, Range 30 West, Brown County, Minnesota, containing 26.37 acres, more or less,
- Parcel 11 - Sublot N of Government Lots 10 and 11, Section 34, Township 110 North, Range 30 West, Brown County, Minnesota, containing 15 acres, more or less,
- Parcel 12 - Part of Government Lots 10 and 11, North of Railway, Section 34, Township 110 North, Range 30 West, Brown County, Minnesota, containing 15.69 acres, more or less,
- Parcel 13 - Railroad Lands in Section 34, Township 110 North, Range 30 West, Brown County, Minnesota, containing 3.63 acres, more or less.

Section 2. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State and the County Auditor of Brown County, Minnesota.

Section 3. This ordinance shall take effect and be in force thirty (30) days from and after its passage, approval and publication and the filing of the certified copies as hereinbefore directed.
