ORDINANCE NO. 1256

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO INCLUDE CERTAIN UNINCORPORATED TERRITORY COMPLETELY SURROUNDED BY LAND WITHIN THE CITY LIMITS AND ABUTTING THEREON.

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, village or borough;

WHEREAS, this territory is completely surrounded on all sides by land already included within the corporate limits of the city and is deemed to be urban in character;

THE COMMON COUNCIL OF THE CITY OF AUSTIN HEREBY ORDAINS:

SECTION 1: Territory annexed. The corporate limits of the City of Austin, Minnesota, are hereby extended to include the territory described as follows, which territory now is and has heretofore been completely surrounded by territory already included within the City limits:

Beginning at a point 243 feet westerly of the southwest corner of O.L. 1 of Southlawn Third Addition to the City of Austin, Mower County, Minnesota. This point also being on the south property line of 10th Place S. W.; thence southerly at a right angle to 10th Place S. W. a distance of 200 feet; thence westerly at a right angle a distance of 235 feet; thence northerly at a right angle a distance of 200 feet to the south property line of 10th Place S. W.; thence easterly along the south property line of 10th Place S. W. a distance of 235 feet to the point of beginning.

1.08 acres.

SECTION 2: Filing. The City Recorder is directed to file certified copies of this ordinance with the Secretary of State, the County auditor of the County in which the property is located, the Township Clerk of the Township in which the property is located, and the Minnesota Municipal Commission.

SECTION 3: Effective date of Annexation. This Ordinance takes effect upon passage and publication and the filing of certified copies as directed in Section 2.

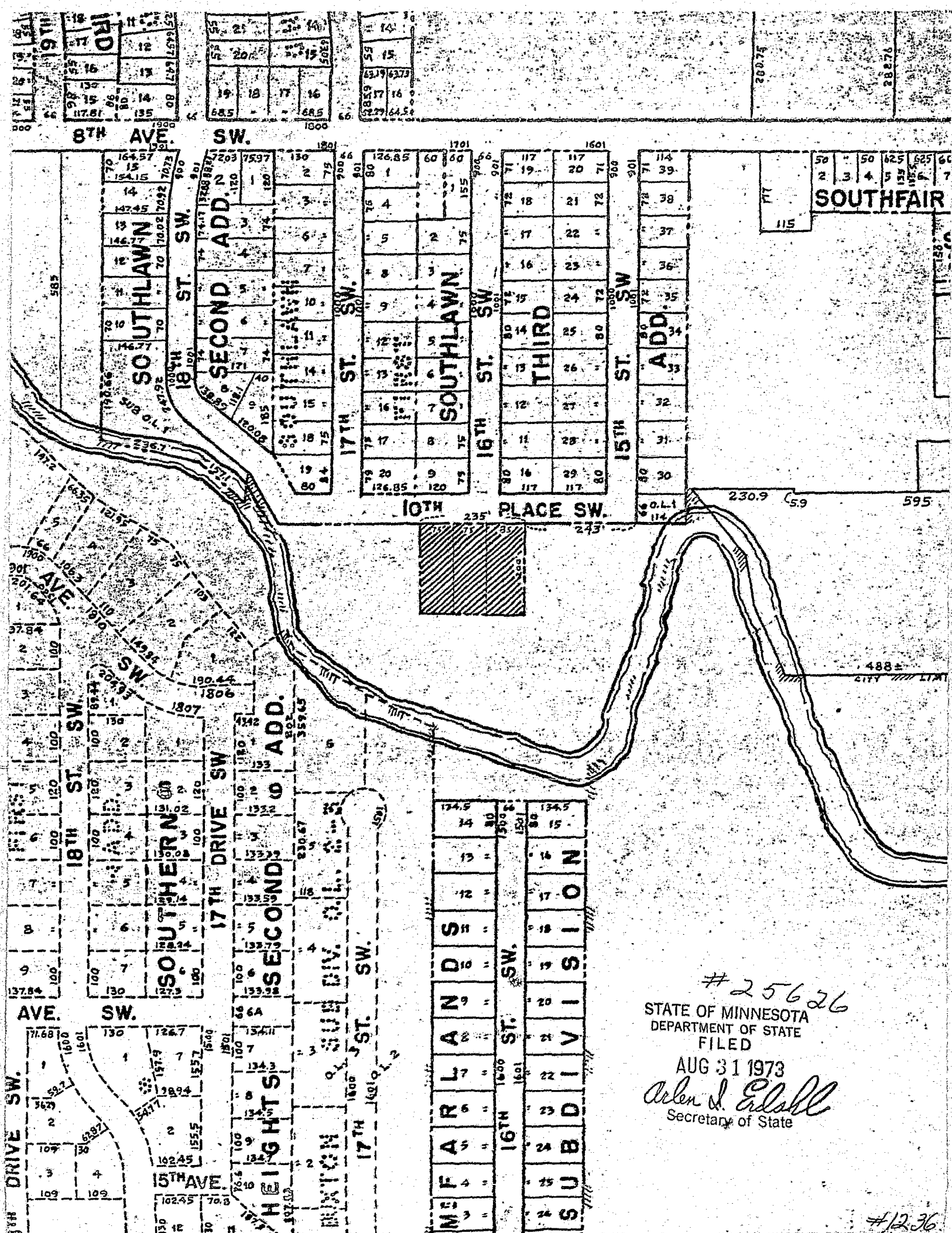
