ORDINANCE NO. 1236

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO INCLUDE CERTAIN UNINCORFORATED TENRITORY COMPLETELY SURROUNDED BY LAND WITHIN THE CITY LIMITS AND ABUTTING THEREON.

WHEREAS, cortain territory described below is not presently included within the corporate limits of any incorporated city, village or borowsha

WIEREAS, this territory is completely surrounded on all eidge by land already included within the corporate limits of the city and in decimed to be urban in character;

THE COMMON COUNCIL OF THE CITY OF AUSTIN HEREDY ORDAINS:

SECTION 1: Torritory annexed. The corporate limits of the City of Austin, Minnesota, are hereby extended to include the territory described as follows, which territory now is and has heretofore been completely surrounded by territory already included within the City Limites

> Engineers of a point 243 feet Westerly of the Southwest corner of O.L. 1 of Southlown Third Addition to the City of Austin, Nover County, Minnesota. This point aloo being on the South property line of loth Place S. W.; thence Southerly at a right angle to loth Place S. W. o distance of 200 feet; thence Westerly of a right ongle a distance of 235 feet; thence Northerly at a right engle a distance of 200 feet to the South property line of loth Place S. W.; thance Easterly along the South property line of 10th Place S. W. a distance of 295 feet to the point of hoginalny.
