Ordinance No. 95

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF LAMBERTON TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEDING 200 ACRES IN AREA ABUTTING ON THE VILLAGE LIMITS

WHEREAS, a certain petition dated May 31, 1972, requesting annexation of the territory hereinafter described was duly presented to the Council on the 31st day of May, 1972; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is approximately 1 1/8th acre of unplatted land, no part of which is included within the limits of an incorporated city, village or borough; and

WHEREAS, the petition was signed by all of the owners, and WHEREAS, no objections to the annexation have been received from the town board, the county, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the village limits on the southwest boundary thereof:

The Council of the Village of Lamberton, Minnesota, ordains:

Section 1. The village council hereby determines (1)

that the annexation will be to the best interests of the village and of the territory affected; (2) that the territory described herein abuts upon the village limits and is urban or suburban in character; and (3) that none of said territory is now included with the limits of any city, village, or borough.

Section 2. The corporate limits of the Village are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the Village as effectually as if it had originally been a part thereof:

Commencing at a point 66 feet East of the Southeast corner of Lot Number Six (6) of Auditor's Subdivision Number One (1) of the Southeast Quarter (SE1/4) of the Northeast Quarter (NE%) and the East One-half (E%) of the Southeast Quarter (SE%) of Section Twenty-two (22), Township One Hundred Nine (109), Range Thirty-seven (37), and the South One-half (S_2^1) of the Northwest Quarter (NW社) and Southwest Quarter (SW社) of Section Twenty-three (23), Township One Hundred Nine (109), Range Thirty-seven (37), said point being on the easterly right of way of County State Aid Highway #6 also designated as Ilex Street, thence running West a distance of 20 rods, thence North a distance of 10 rods, thence East a distance of 20 rods to a point on the easterly right of way of County State Aid Highway #6 also designated as Ilex Street, thence South along said right of way 10 rods to the point of beginning.

Section 3. <u>Filing</u>. The Village clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

Section 4. <u>Effective date</u>. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
