ORDINANCE NO. 191

ORDINANCE ANNEXING ADJOINING LANDS

The City Council of the City of Madison do ordain:

Section 1: That the following described land adjoining the limits of the City of Madison, located in the County of Lac qui Parle, State of Minnesota, is hereby added to, taken into and made a part of the City of Madison, to-wit:

Tract No. 1: Lot Fourteen (14), excepting therefrom the north 20 feet thereof, the West 50 feet of the East 350 feet of Lot Fifteen (15), excepting therefrom the north 20 feet thereof; the West 50 feet of the East 350 feet of Lot Sixteen (16), and all of Lot Seventeen (17), all in Evergreen Addition to Madison, according to the plat thereof on file and of record in the office of the Register of Deeds of said county, said land being situated in the SE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 21, Township 41S North, Range 44 West, together with that part of the City of Madison street dedicated as Park Avenue and the Madison Township road right of way located between said Lot 14, except the north 20 feet thereof and said Lot 17 and the present corporate limits of the city of Madison.

Tract No. 2: Lots Fifteen (15) and Sixteen (16) of Evergreen Addition to Madison, excepting therefrom the east 350 feet thereof, as measured along the north line of said Lot 16, also excepting from the said Lot 15, the north 20 feet thereof, according to the plat thereof on file and of record in the office of the Register of Deeds in and for Lac qui Parle County, Minnesota.

Section 2: That on the taking effect of this ordinance the corporate limits and boundary lines of the City of Madison shall be and are extended to include said tracts of land.

Section 3: This ordinance shall be in full force thirty days from and after its passage.
