ORDINANCE NO. 37

An ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF DOUGE CENTER TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEPDING 200 ACRES IN AREA ABUTTING UPON THE VILLAGE LIMITS.

WHEREAS, a certain petition requesting annexation of the territory hereinafter described was duly presented to the Council on the 13th day of Murch, 1973; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is approximately 95 acres of unplatted land, no part of which is included within the limits of an incorporated city, village, or borough; and WHEREAS, the petition was signed by all owners; and

WHEREAS, no objections to the annexation have been received from the Town Board, the County Board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHETEAS, a Resolution of the Township Board of Ashland Township consenting to said annexation has been filed with the Village Clerk; and

WHEREAS, the land described in the metition abuts upon the village limits at the South boundary thereof;

The Council of the Village of Dodge Center, Minnesota, ordains:

Section 1. The Village Council hereby determines (1) that the annexation will be to the best interests of the Village and of the territory affected; (2) that the territory described herein abuts upon the Village limits and is urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village, or borough.

Section 2. <u>Tarritory Annexed</u>. The corporate limits of the Village are hereby extended to include the unpletted land described as follows and the same is hereby annexed to and included within the Village as effectually as if it had originally been a part thereof:

A. Commencing at the Northwest corner of the Northwest Quarter (NV) in Section Three (3). Toumship One Hundred Six (106) North of Range Seventeen (17) Next, thence running South Three Hundred and Ninety (392) feet, thence East Four Hundred and Forty six (116) feet, thence North Sixty (10) feet, thence East Two hundred and fourteen (211) feet, thence North Three hundred and thirty (330) feet, thence West Six Hundred and Sixty (660) feet, to the place of beginning, containing 5.61 scree, more or less.

- B. Beginning at the Northeest corner of the West Half of the Worthwest Quarter (M. N.M.), Section Three (3), To-nship One Hundred Cix (106) North of Renge Seventeen (17) West, thence West Forty (AO) rods, thence South Tonty (20) rods, thence East Forty (AO) rods, thence North Twenty (20) rods, to the place of beginning, containing five peres more or less. .
- G. The East Half (E1) of the Northwest Quarter (NS1) of Section Three (3); and that mort of the Northeast Quarter (NE1) lying West of the Chicago and Great Wastern Reilroad in Section Three (3), Township One Hundred Six (106) North of Range Seventeen (17) Yest.

All in Dodge County, Minnesota.

Section 3. Zoning District. Said ennexed territory shall be in the Industrial District.

Section 4. Filing. The village clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State and the County Auditor.

Section 5. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3. Adopted by the Council this 26th day of April
