ORDER

The Minnesota Municipal Commission received a petition by the landowners for the detachment of land from the Village of Lanesboro, Minnesota on the 2nd day of May, 1973. A resolution for the detachment of the same land was filed by the Village of Lanesboro on the 2nd day of May, 1973.

The territory involved consists of the following:

The south half of the southwest quarter, Section 18, Township 103 north, Range 9 west, subject to existing highway easements, and containing 80 acres of land, more or less, according to the U. S. Government survey thereof.

The property is adjacent to the Township of Holt and said lands are unplatted and used for agricultural purposes. The petition is in proper legal form and sets forth the information required in Minn. Stat. 414.06 and upon the files and records, the Minnesota Municipal Commission hereby issues its Order.

IT IS HEREBY ORDERED: That the foregoing described real property be, and the same hereby is, detached from the Village of Lanesboro and made a part of the Township of Holt, Fillmore County, Minnesota, the same as if it had originally been made a part thereof.

~~IT IS FURTHER ORDERED: That the population of the Township of Holt is hereby increased by two (2) and the Village of Lanesboro is hereby decreased by two (2) for all purposes until the next federal census.~~
