REORGANIZATION ORDER NUMBER 27

Pursuant to Minnesota Statutes 16.125, 16.13 and 16.135, the following administrative reorganization is hereby made effective August 1, 1973.

The preparation of the fiscal documents to disburse funds from the Peace Officers Benefit Fund, as required by Minnesota Law 1973, Chapter 248, Section 4, is hereby transferred from the State Auditor to the Department of Labor and Industry.

This transfer does not affect the signatory and certification of fund authority of the State Auditor, but is intended to improve the administrative portion by placing the accountability for preparation of the applicable fiscal documents in the Department of Labor and Industry.

This order is effective August 1, 1973.

Reorganization Order Number 27

This transfers the processing of the invoice and warrant from the State Auditor to the Department of Labor and Industry. This leaves only the approving function within the Auditor's Office.

Currently, the Workmen's Compensation Commission would issue an order to pay the benefit and the State Auditor would prepare the invoice or abstract and then the warrant. After reorganization order 27, the Department of Labor and Industry would prepare the invoice and warrant and then get the Auditor's certification and signature on the warrant as required in M.S. Chapter 16.16, Subd. 8.

The fund established by appropriation in M.L. 1973, Chapter 248, Section 5, remains in the State Treasury.

M.L. Chapter 248, was effective January 1, 1973.
