ORDINANCE NO. 543

AN ORDINANCE DECLARING CERTAIN LAND FULLY OWNED  
BY THE CITY OF NORTH MANKATO TO BE ANNEXED TO  
THE CITY OF NORTH MANKATO.

The Common Council of the City of North Mankato, Minnesota, does  
ordain as follows:

Sec. 1. That the following described parcels of land, wholly  
owned by the City of North Mankato, together with any and all streets,  
highways or other public rights-of-way within and adjacent to said land,  
be and hereby is annexed and declared to be a part of the City of North  
Mankato pursuant to Minnesota Statute 414.033, Subdivision 2:

PARCEL NO. 1

Commencing at the northwest corner of the southeast quarter  
of the southwest quarter of Section 2, Township 108 north,  
Range 27 west; thence east 330 feet along the north line of  
SE 1/4 of SW 1/4 of Section 2; thence south 660 feet, thence  
west 330 feet; thence north 660 feet along the west line of  
SE 1/4 of SW 1/4 of Section 2, to the point of beginning.  
Also known as the west 5 acres of NW 1/4 of SE 1/4 of SW 1/4  
of Section 2, T108N, R27W. The land described above contains  
5 acres.

PARCEL NO. 2 That part of the following described parcel  
lying outside of the corporate limits of the City:  
Beginning at the NE corner of SE 1/4 of SE 1/4 of Section 10,  
T108N, R27W, thence 468.5 feet westerly along said quarter  
line; thence 33 feet south to point of beginning, which is  
the southwest corner of the intersection of Marie Lane and  
South Marquette Avenue; thence 350 feet southerly along west  
right of way of South Marquette Avenue, thence 622.29 feet  
westerly and parallel to south right of way line of Marie  
Lane; thence 350 feet northerly and parallel to said right  
of way line of South Marquette Avenue to the south right of  
way line of Marie Lane; thence 622.29 feet easterly along  
said south right of way line of Marie Lane to the point of  
beginning, containing 5 acres.

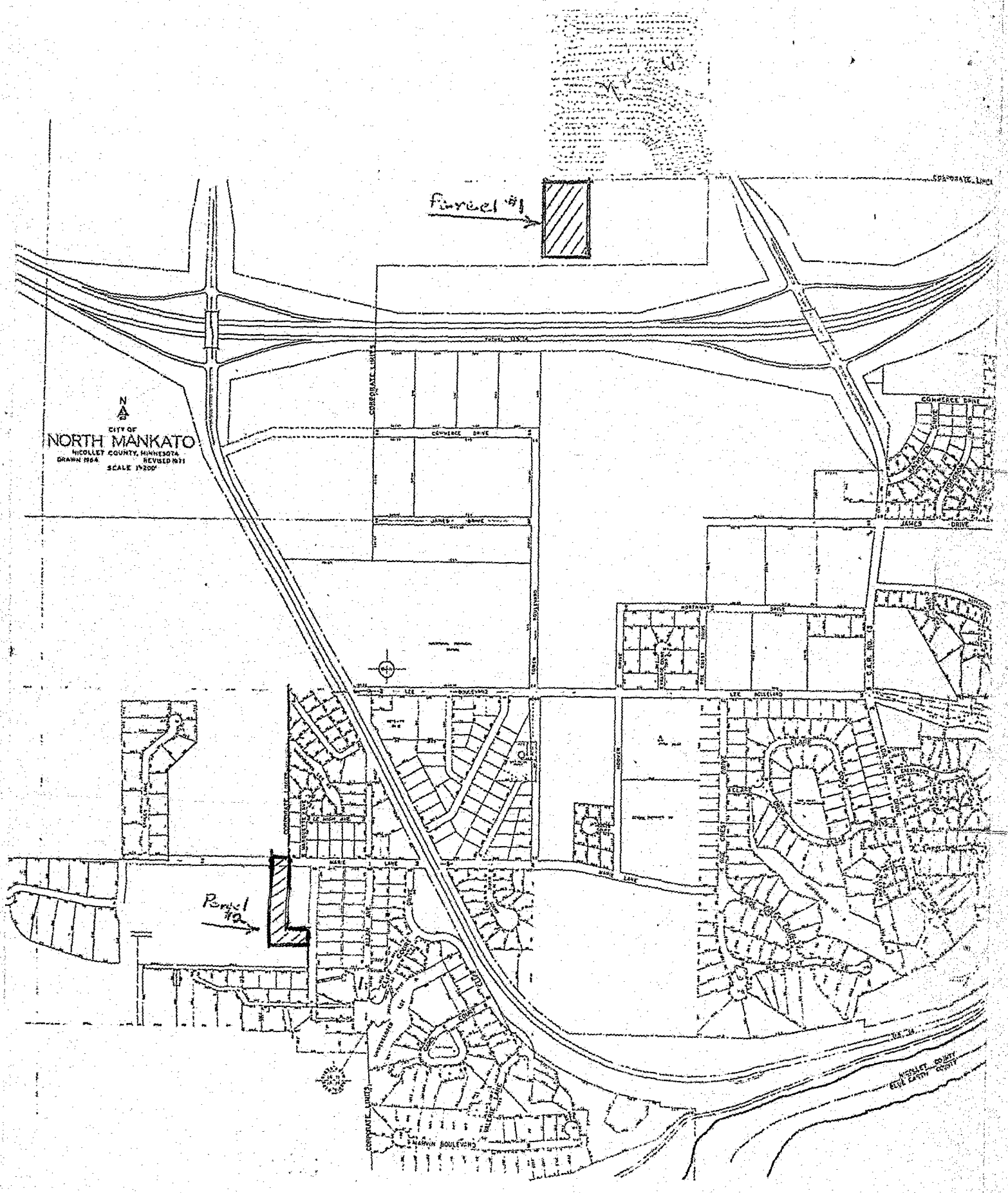
Sec. 2. This Ordinance shall take effect from and after its date

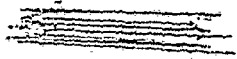

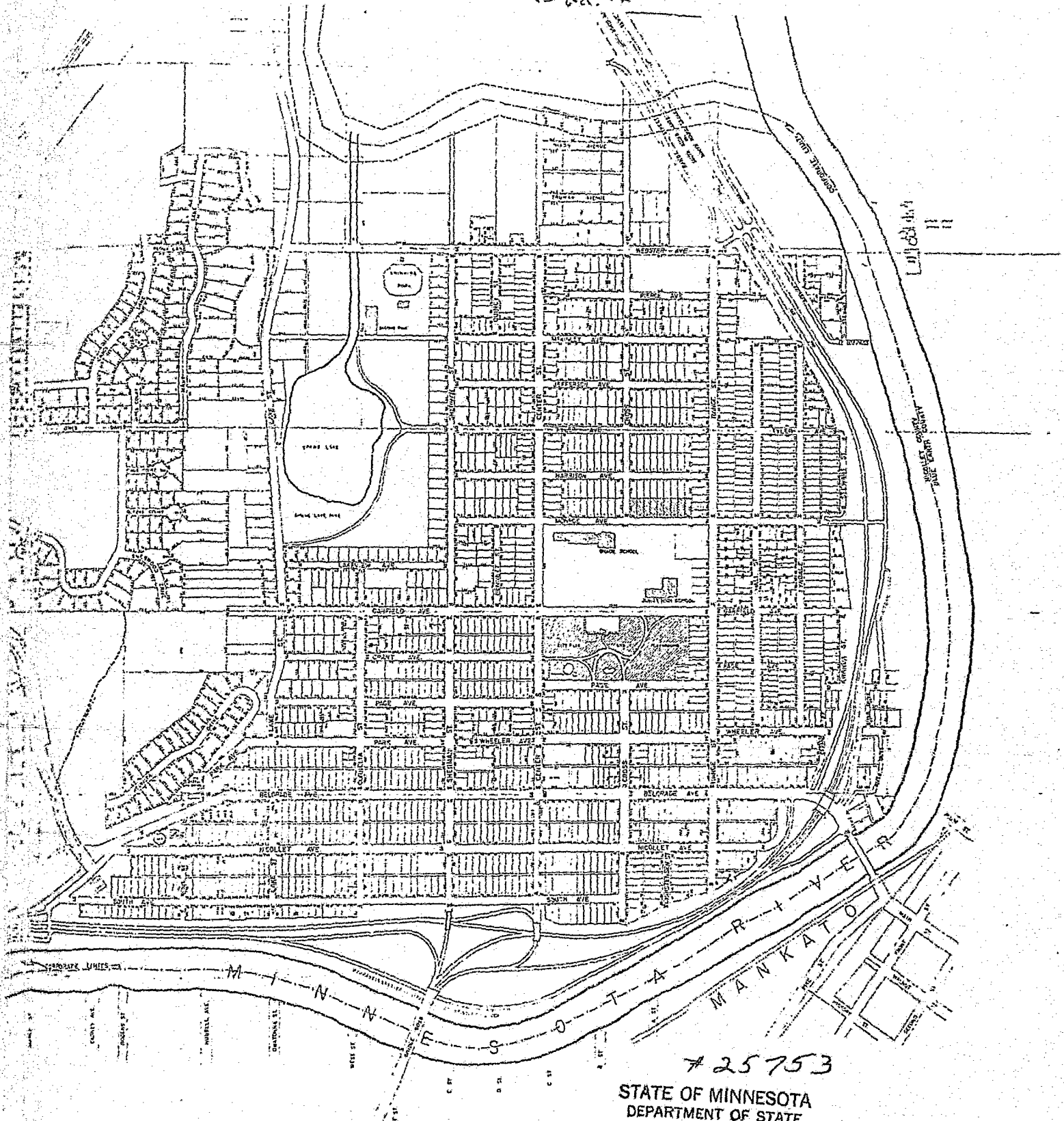
