 seventeen, [ 17 ], Bissell's Statutes, relating to railroad companies organized  
 under the laws of the state of Iowa; and approved on February 21st. 1877:  
 and the same being section one hundred and six, [ 106 ], of chapter, thirty  
 four, [ 34 ], of the General Statutes of 1878 of the state of Minnesota.  
 This acceptance is made for the purpose of complying with said laws, and of  
 filing the same in the office of the Secretary of the said state of Minnesota.
