ORDINANCE NO. 86

AN ORDINANCE ANNEKING CERTAIN
ABUTTING PROPERTY TO THE CITY OF
WINTHROP, SIBLEY COUNTY, MINNESOTA

THE CITY COUNCIL OF THE CITY OF WINTHROP ORDAINS AS FOLLOWS:

WHEREAS, Lester H. Damrow and Florence M. Damrow have duly filed a Petition with the City Council of the City of Winthrop requesting that a certain parcel of land, hereinafter described, be annexed to and made a part of the City of Winthrop;

AND WHEREAS, the Council, upon investigation, finds that the Petition so filed does in all particulars comply with the statutes of the State of Minnesota governing the annexation of territory to a city of the Fourth Class; that the Petitioners are the sole and only owners of the tract of land, hereinafter described; and that the said tract of land does in fact abut the City of Winthrop;

NOW THEREFORE, The City Council of the City of Winthrop ordains that that certain parcel of land, described as follows:

A parcel of land in the Southwest Quarter of the Southwest Quarter of Section Number Thirty-two (32), Township Number One Hundred Thirteen (113) North of Range Number Twenty-nine (29) West, described as follows:

Beginning at a point 230 feet East and 50 feet North of the Southwest Corner of Sec. 32, Twp. 113, Rge. 29, said point lying on the Northerly right of way limits of Trunk Highway No. 19, as it is now located, thence running North, and at a right angle to said Trunk Highway No. 19 for a distance of 217.8 feet, thence running East and parallel to Trunk Highway 19, for a distance of 75 feet, thence running South for a distance of 217.8 feet to the northerly right of way limits of Trunk Highway 19, thence running West on a line coincident with the Northerly right of way limits of Trunk Highway No. 19 for a distance of 75 feet to the point of beginning, containing .375 acres more or less;

is hereby declared to be annexed to the City of Winthrop and is made a part of the said city as effectually as if it had been originally a part thereof.

THIS ORDINANCE shall be in full force and effect from and after its passage and publication according to Law, and the City Clerk is authorized and directed to cause certified copies of said Ordinance to be recorded and filed with the proper authorities in accordance with the Law.

THIS ORDINANCE Adopted by the City Council of the City of Winthrop, Sibley County, Minnesota, this 4th day of September, 1973.
