ORDINANCE NO. 651

AN ORDINANCE PROVIDING FOR THE ANNEXATION OF  
W. W. THOMPSON REALTY TO THE CITY OF BRAINERD

The Council of the City of Brainerd do ordain:

SECTION 1. That W. W. Thompson, the fee owner of:

All that part of Government Lot 2 (NW $\frac{1}{4}$  of NE $\frac{1}{4}$ ) and Government Lot 3 (NE $\frac{1}{4}$  of NW $\frac{1}{4}$ ) lying East of Highway 371 and West of Burlington Northern Railroad right-of-way, the NW $\frac{1}{4}$  of the NW $\frac{1}{4}$ , and that part of the SW $\frac{1}{4}$  of the NW $\frac{1}{4}$  lying North of the Burlington Northern Railroad right-of-way, all in Section 1, Township 44 North, Range 31 West, Fourth Prime Meridian,


filed a petition with the Council of the City of Brainerd on March 2, 1973 requesting that said realty be annexed to the City of Brainerd.

SECTION 2. That pursuant to Minnesota Statute 414.033, more than 60 days have elapsed since the filing of said petition and no objections have been filed or received by the Council of the City of Brainerd.


