ORDINANCE NO. 113

AN ORDINANCE EXTENDING THE CORPORATE LIMITS
OF THE VILLAGE OF NORWOOD TO INCLUDE CERTAIN
UNINCORPORATED UNPLATTED LAND NOT EXCEEDING
200 ACRES IN AREA ABUTTING UPON THE VILLAGE LIMITS.

WHEREAS, a certain petition requesting
annexation of the territory hereinafter described was duly presented
to the council on the 14th day of May, 1973; and

WHEREAS, the quantity of land embraced
within the area described in the petition and bounded as described is
less than one (1) acre of unplatted land, no part of which is included
within the limits of an incorporated city, village, or borough; and

WHEREAS, the petition was signed by
all owners; and

WHEREAS, no objections to the
annexation have been received from the town board, the county board,
or the governing body of any municipality whose boundaries abut upon
the boundaries of the land so be annexed; and

WHEREAS, the land described in the
petition abuts upon the village limits at the south boundary thereof;
The council of the Village of Norwood, Minnesota, ordains:

Section 1. The village council hereby
determines (1) that the annexation will be to the best interests of the
village and of the territory affected; (2) that the territory described
herein abuts upon the village limits and is urban or suburban in
character; and (3) that none of said territory is now included within
the limits of any city, village, or borough.

Section 2. Territory Annexed. The
corporate limits of the village are hereby extended to include the
unplatted land described as follows and the same is hereby annexed to and
included within the village as effectually as if it had originally
been a part thereof:

Commencing at a point which is 33 feet South thence 829.92 feet East
of the SW Corner of the NW 1/4 of the SE 1/4 of Section 14, Township
115, Range 26; thence running South 367.4 Feet; thence West 237.4
feet, thence North 367.4 feet, thence East 237.4 feet to the place
of beginning, excepting therefrom the following three (3) tracts
of land:

A) Commencing at a point which is 33 feet South thence 829.92 feet
East of the SW corner of the NW 1/4 of the SE 1/4 of Sec. 14,
Township 115, Range 26; thence running South 197.4 feet to the

point of beginning of the land to be herein described; thence continuing South on the same line a distance of 170 feet to a point; thence West 237.4 feet; thence North 170 feet; thence East 237.4 feet to the place of beginning.

B) Commencing at a point which point is 33 feet South thence 828.92 feet East of the SW corner of the NW 1/4 of the SW 1/4 of Section 14, Township 115, Range 26, thence running South 197 feet to a point; thence West 77 feet to a point; thence North 197 feet to a point; thence East 77 feet to the point of beginning.

C) Commencing at a point, which point is 33 feet South, thence 675.92 feet East of the SW Corner of the NW 1/4 of SW 1/4 of Section 14-115-26; thence running South 197 feet to a point; thence West 90 feet to a point; thence North 197 feet to a point; thence East 90 feet to the point of beginning;

Section 3. Filing. The village

clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
