ORDINANCE NO. 63

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF CLEARBROOK TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE VILLAGE LIMITS.

WHEREAS, a certain petition dated May 22, 1973, requesting annexation of the territory hereinafter described was duly presented to the Council on the 25th day of May, 1973; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is approximately one and one-fourth acres of unplatted land, no part of which is included within the limits of an incorporated city, village, or borough; and

WHEREAS, the petition was signed by all the owners; and

WHEREAS, no objections to the annexation have been received from the town board, the county board, or any other party; and

WHEREAS, the land described in the petition abuts upon the village limits at the southeast boundary thereof;

The Council of the Village of Clearbrook, Minnesota, ordains:

Section 1. Annexation. The village council hereby determines (1) that the annexation will be to the best interests of the village and of the territory affected; (2) that the territory described herein abuts upon the village limits and is urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village, or borough.

Section 2. Territory Annexed. The boundaries of the territory which are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the village as effectually as if it had originally been a part hereof:

That property enclosed by a line commencing at the NW corner of the SW 1/4, Section 29-149-37, thence South along the east line of said SW 1/4 605 foot to the point of beginning, thence West 220 foot more or less to the village limits of the Village of Clearbrook, thence South 250 foot, thence East 220 foot, thence North 250 foot to the point of beginning; and also all abutting streets.

Section 3. Filing. The village clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
