ORDINANCE NO. 507

AN ORDINANCE ANNEXING PROPERTY OWNED BY  
THE CITY OF STILLWATER TO THE CITY  
OF STILLWATER AND ABUTTING THEREON

THE CITY COUNCIL OF THE CITY OF STILLWATER DOES ORDAIN:

Section 1. That the following described unincorporated land is owned by the City of Stillwater and abuts upon the City of Stillwater and is thereby deemed to be urban in character, to-wit:

That part of the Southwest Quarter of the Northeast Quarter (SW $\frac{1}{4}$  of NE $\frac{1}{4}$ ) of Section Thirty-one (31), Township Thirty (30), Range Twenty (20), Washington County, Minnesota, described as beginning at the Southeast corner of said Southwest Quarter of the Northeast Quarter; thence on an assumed bearing of North 1° 27' 14" West along the East line of said Southwest Quarter of Northeast Quarter a distance of 27.87 feet; thence North 89° 18' West 237.32 feet; thence North 0° 42' East 486.0 feet; thence North 13° 44' West 207.95 feet; thence South 83° 26' 23" West 56.64 feet; thence South 52° 26' West 82 feet; thence South 40° 05' West 389.97 feet; thence South 26° 35' 48" East 122.81 feet; thence South 47° 25' West 317.21 feet; thence North 48° 49' West 319 feet; thence North 65° 18' West 179 feet; thence North 8° 57' West 129 feet; thence North 38° 36' East 287.18 feet; thence North 21° 12' 17" West 227.90 feet; thence North 44° 43' East 430 feet; thence North 47° 24' West 168.61 feet more or less to the North line of said Southwest quarter of Northeast Quarter; thence Westerly along said North line to the Northwest corner of said Southwest Quarter; thence Southerly along the West line of said Southwest Quarter to the Southwest corner of said Southwest Quarter; thence Easterly along the South line of said Southwest Quarter to the point of beginning, excepting therefrom that part of said Southwest Quarter of Northeast Quarter lying West of Long Lake in said Section 31.

Section 2. That the City of Stillwater deems it to be in the best interests of the City of Stillwater and of the territory affected that the above described property owned by the City of Stillwater be annexed to the City of Stillwater, and the same is hereby annexed, added to, taken into, and made a part of the City of Stillwater, and is assigned to and made a part of election districts in the City of Stillwater as follows: First Ward, Second Precinct.

Section 3. That this ordinance shall be in full force and effect from and after its passage and publication according to law and the Charter of the

City of Stillwater.
