ORDINANCE NO.

AN ORDINANCE ANNEXING PROPERTY TO THE CITY OF STILLWATER WHICH ABUTS UPON THE CITY OF STILLWATER AND IS COMPLETELY SURROUNDED BY LAND WITHIN ITS MUNICIPAL LIMITS.

THE CITY COUNCIL OF THE CITY OF STILLWATER DOES ORDAIN:

Section 1. That the following described unincorporated land abuts upon the City of Stillwater and is completely surrounded by land within the municipal limits of the City of Stillwater, and is thereby deemed to be urban in character, to-wit:

That part of the Southwest Quarter of the Northeast Quarter (SW2 of NEZ) of Section Thirty-one (31), Township Thirty (30), Range Twenty (20), Washington County, Minnesota, described as commencing at the Southeast corner of said Southwest Quarter of Northeast Quarter; thence on an assumed bearing of North 1º 27' 14" West along the East line of said Southwest Quarter of Northeast Quarter a distance of 27.87 feet to the actual point of beginning of the land to be hereinafter described; thence North 89° 18' West 237.32 feet; thence North 0° 42' East 486.0 feet; thence North 13° 44' West 207.95 feet; thence South 83° 26' 23" West 56.64 feet; thence South 52° 26' West 82 feet; thence South 40° 05' West 389.97 feet; thence South 26° 35' 48" East 122.81 feet; thence South 47° 25' West 317.21 feet; thence North 48° 49' West 319 feet; thence North 65° 18' West 179 feet; thence North 8° 57' West 129 feet; thence North 38° 36' East 287.18 feet; thence North 21° 12' 17" West 227.90 feet; thence North 44° 43' East 430 feet; thence North 44° 24' West 168.61 feet more or less to the North line of said Southwest quarter of Northeast Quarter; thence Easterly along said North line to the Northeast Corner of said Southwest Quarter; thence Southerly along the East line of said Southwest Quarter to the point of beginning.

Section 2. That it is in the best interests of the City of Stillwater and of the territory affected that the same is hereby annexed, added to, taken into, and made a part of the City of Stillwater, and is assigned to and made a part of election districts in the City of Stillwater as follows: Second Ward, Second Precinct.

Section 3. That this ordinance shall be in full force and effect from and after its passage and publication according to law and the Charter of the City of Stillwater.
