ORDINANCE NO. 465

AN ORDINANCE ANNEXING LAND
TO THE CITY OF WHITE BEAR LAKE, MINNESOTA

WHEREAS, the owners of all of the land hereinafter described, which is unplatted and does not exceed 200 acres, have petitioned the City Council of the City of White Bear Lake, Minnesota, to have said land annexed to the City of White Bear Lake, Minnesota; and

WHEREAS, a copy of said Petition was filed with the required governmental units and the Minnesota Municipal Commission, and

WHEREAS, no written objections to such annexation have been submitted to the Minnesota Municipal Commission or the City of White Bear Lake within the 30 days period required by Minnesota Statutes, and

WHEREAS, the City Council feels that such annexation will be to the best interest of the City of White Bear Lake and of the territory affected,

NOW, THEREFORE, The Council of the City of White Bear Lake, Minnesota, does ordain:

1. That the following described land situated in Ramsey County, Minnesota, to-wit:

Subject to Otter Lake Road, the south 80 feet of the north 301.61 feet of the east 233 feet of part of Government Lot 2 in the Southwest Quarter of Section 15, Township 30, Range 22

and

Subject to Birch Lake Boulevard North, and except the north 301.61 feet the west 100 feet of the east 133 feet of part of Government Lot 2 in the Southwest Quarter of Section 15, Township 30, Range 22

and


South 24.61 feet of north 221.61 feet of east 233 feet of part of Government Lot 2 in the Southwest Quarter and north 110 feet of west 110 feet of the east 343 feet of part of Government Lot 2 lying south of the following described line: Commencing at a point 128 feet north and 328.42 feet west of the centerline of Section 15 thence south 6 degrees 58 minutes west 286.83 feet thence south 83 degrees 02 minutes east 15 feet to beginning of line to be described, thence east parallel with the north line of Southwest Quarter across said part of Government Lot 2 (Subject to Otter Lake Road) in Section 15, Township 30, Range 22.


be and the same is hereby annexed to the City of White Bear Lake, Minnesota.

2. That upon the effective date of this Ordinance such land shall become a part of said City as if it has been originally a part thereof.



Passed by the City Council of the City of White Bear Lake, Minnesota, this 28th day of January, 1969.




