

ORDINANCE NO. 242

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF EAST GRAND FORKS, TO INCLUDE CERTAIN UNPLATTED LANDS IN THE EAST 1/2 OF SECTION 35, TOWNSHIP 152 NORTH, RANGE 50 WEST OF THE 5TH PRINCIPAL MERIDIAN, POLK COUNTY, MINNESOTA, NOT EXCEEDING 200 ACRES, WHICH TRACT CONTAINS 5.00 ACRES

The City Council of the City of East Grand Forks, Minnesota, do ordain:

Section 1. A petition has been filed with the City Council of the City of East Grand Forks, Minnesota, by John P. Bushee and Ann M. Bushee, husband and wife, being all of the owners of the land hereinafter described, to have such land included within the City Limits of the City of East Grand Forks, Minnesota, that copies of said petition were filed with the Minnesota Municipal Commission, the Town Board of Grand Forks Township and the County Board of Polk County, Minnesota; that more than sixty (60) days have elapsed since such filings of said petition, and that no objections have been filed as is more fully shown by the records and files herein.

Section 2. That the tract of land being annexed is described as follows; to-wit:

That part of the East Half of the Northeast Quarter (E 1/2 NE 1/4) of Section Thirty Five (35), Township One Hundred Fifty Two (152) North of Range Fifty (50) West of the Fifth Principal Meridian, described as follows, to-wit:

Commencing at a point where the West line of the E 1/2 NE 1/4 of said Section Thirty Five (35), intersects the North line of Seventeenth Avenue North, in the City of East Grand Forks; thence North along said West line of the E 1/2 NE 1/4 of said Section Thirty Five (35), a distance of 466.69 feet; thence East parallel to and 466.69 feet North of the North line of said Seventeenth Avenue North a distance of 466.69 feet; thence South parallel to and 466.69 feet East of the West line of said E 1/2 NE 1/4 of said Section Thirty Five (35), a distance of 466.69 feet to the North line of Seventeenth Avenue North; thence West along the North line of said Seventeenth Avenue North a distance of 466.69 feet to the point of beginning.

Section 3. That the quantity of said land herein described is 5.00 acres.

Section 4. That the City Council hereby determines:

1. That the quantity of land embraced within the foregoing description is less than 200 acres.

2. That the annexation will be to the best interests of the City of East Grand Forks, Minnesota, and of the territory affected.

3. That the territory and land described above abuts the City of East Grand Forks, Minnesota, is suitably conditioned for municipal government, and is urban in character.

4. That the petition for annexation was signed by all of the owners of the land and real estate hereinabove described.

Section 5. The corporate limits of the City of East Grand Forks, Minnesota, are hereby extended to include the property described in Section 2, and the same is hereby annexed to and included in the City of East Grand Forks, Minnesota, as effectually as if it had originally been a part thereof.

Section 6. The Clerk-Treasurer is hereby directed to file certified copies of this Ordinance with the State of Minnesota Municipal Commission, the County Auditor, the Town Clerk and the Secretary of the State of Minnesota.

Section 7. This Ordinance takes effect upon its passage and publication, and the filing of the certified copies as directed in Section 6, and be given the number 242.
