

ORDINANCE NO. 40.1

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF COKATO  
TO INCLUDE CERTAIN OTHER PROPERTY  
OWNED BY AND ABUTTING UPON THE LIMITS OF THE VILLAGE.

WHEREAS, the territory described below is not presently within the corporate limits of any incorporated city, village, or borough; and,

WHEREAS, this territory abuts upon the corporate limits of the Village of Cokato at the east boundary thereof and it is deemed to be urban in character; and,

WHEREAS, the territory is owned in fee by the Village;

The Village Council of the Village of Cokato ordains:

Section 1. Territory Annexed.

The corporate limits of the Village of Cokato are hereby extended to include the unplatted property described as follows now owned by the Village:

SE 1/4 of SE 1/4, except the north 20 rods thereof, and also except 2 1/4 acres in SE corner of said SE 1/4 of SE 1/4 theretofore sold, the boundary line on west side of said 2 1/4 tract shall be the center of Sucker Creek, all in Section 27, Township 119, Range 28.

Section 2. Filing.

The Village Clerk is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the county in which the property is located, the Minnesota Municipal Commission and the Town Clerk for the Town of Cokato.

Section 3. Effective Date of Annexation.

This ordinance takes effect on its passage and publication and the filing of certified copies as directed in Section 2.

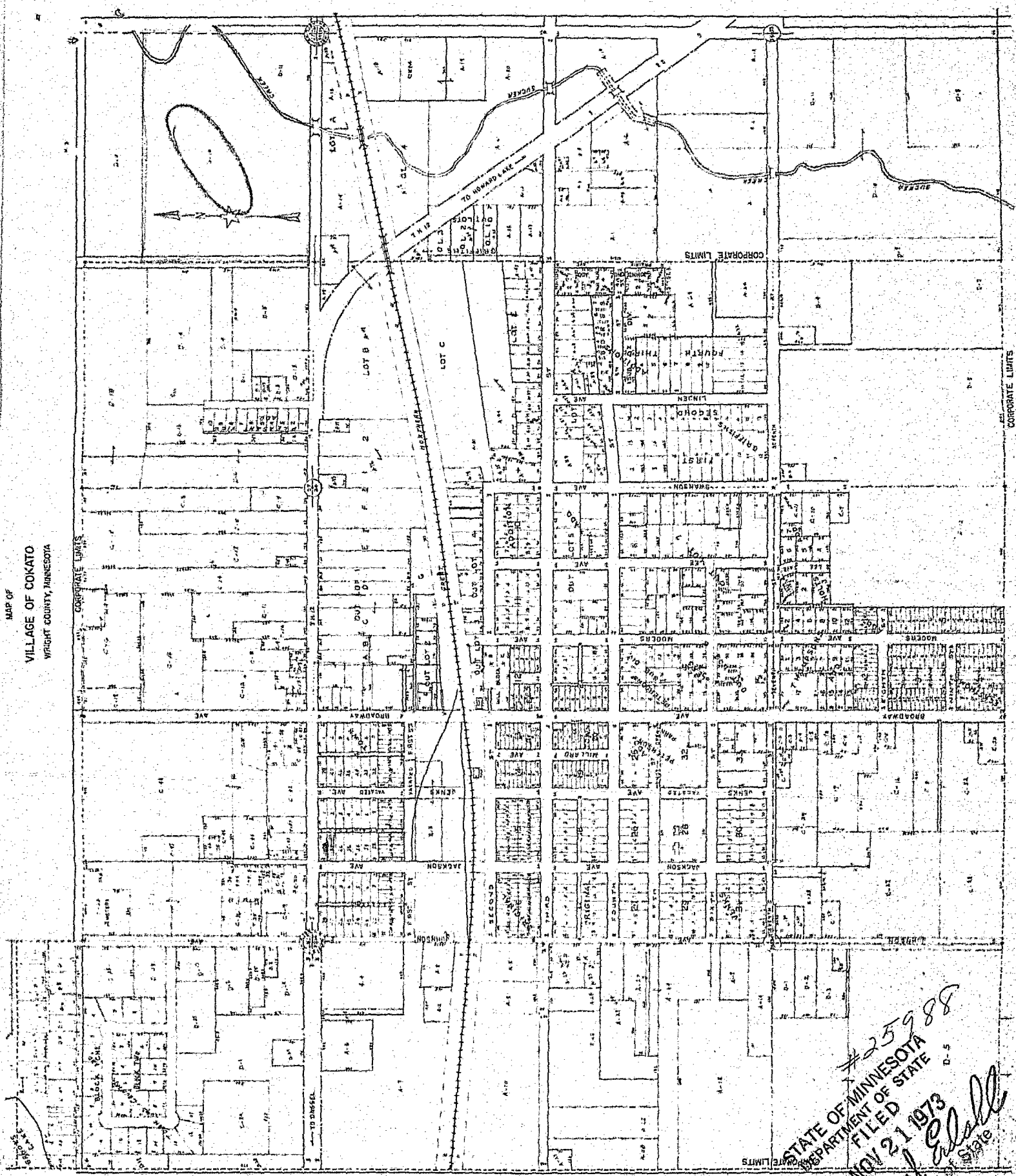
