ORDINANCE NO. 69

AN ORDINANCE ANNEXING CERTAIN LANDS INTO THE CORPORATE LIMITS OF THE VILLAGE OF HAMBURG

Hamburg

WHEREAS, A Petition for Annexation has been filed with the Village of Hamburg for the annexation of the hereinafter described lands into the corporate limits of the Village of Hamburg, and said Petition was signed by all of the owners of the hereinafter described property; and

WHEREAS, More than sixty (60) days have passed since the filing of copies of said Petition with the Carver County Auditor, the Town Clerk of Young America Township, and the Municipal Commissioner of the State of Minnesota as provided by Minnesota Statute Section 414.033; and

WHEREAS, No objection whatsoever to said proposed annexation has been made by any person or party; and

WHEREAS, The Village of Hamburg deems that annexation of said property to the Village of Hamburg would be in the best interest of the property and of the Village of Hamburg;

THE VILLAGE COUNCIL OF THE VILLAGE OF HAMBURG, CARVER COUNTY, MINNESOTA, ORDAINS:

Section 1. <u>Declaration</u>. It is hereby determined that the territory described below abuts the present corporate limits of the Village of Hamburg; that said lands are unplatted and do not exceed 200 acres in area; that said lands are not now included in any other municipality; that said lands are conditioned as properly to be subjected to municipal government; and that annexation of said land would be to the best interest of the Village of Hamburg and of the territory to be annexed.

Section 2. <u>Territory Annexed</u>. The corporate limits of the Village of Hamburg are hereby extended to encompass and embrace all of the territory described as follows, to-wit:

That part of the Southeast Quarter of Section 29, Township 115 North, Range 26 West, Carver County, Minnesota, described as follows:

Commencing at the southeast corner of said Southeast Quarter; thence on an assumed bearing of North along the east line of said Southeast Quarter for a distance of 788.28 feet to the actual point of beginning of the land to be described; thence continuing on a bearing of North along said east line of the Southeast Quarter for a distance of 250.00 feet; thence on a bearing of North 89 degrees 35 minutes 00 seconds West parallel with the South line of said Southeast Quarter for a distance of 265.00 feet; thence on a bearing of South parallel with said east line of the Southeast Quarter for a distance of 365.00 feet; thence on a bearing of South 89 degrees 35 minutes 00 seconds East parallel with the said South line of the said Southeast Quarter for a distance of 100.0 feet; thence on a bearing of North parallel with the east line of the Southeast Quarter for a distance of 115.00 feet; thence on a bearing of South 89 degrees 35 minutes 00 seconds 89 degrees 35 minutes 00 seconds West parallel with the south line of the Southeast Quarter for a distance of 165.00 feet to the actual point of beginning;

Section 3. Filing. The City Clerk is hereby directed to file copies of this Ordinance with the Municipal Commission of the State of Minnesota, the

Secretary of State of Minnesota, the County Auditor of Carver County and the Town Clerk of Young America Township.

Section 4. Effective Date of Annexation. Annexation shall be deemed final upon the filing of copies of this Ordinance as directed in Section 3 above.
