ORDINANCE NO. 596

(F-11)

An Ordinance extending the corporate limits of the City of Willmar, Minnesota, a municipal corporation of the State of Minnesota, to include certain lands not exceeding 200 acres.

Whereas, a petition has been filed with the governing body of the City of Willmar, a municipal corporation of the State of Minnesota, by the sole owner having an interest therein, to have certain real property hereinafter described included within the limits of the City of Willmar, Minnesota, and

Whereas, it is proposed to annex by virtue hereof to the said City of Willmar said property, all of which said property is in Kandiyohi County, State of Minnesota, and

Whereas, the property to be annexed consists of approximately 3.7 acres, more or less, described as follows, to-wit:

The North 198.5 feet of the West 2124.5 feet of the South Half of the Northwest Quarter; and that part of Government Lot 3 lying southerly of the southerly right-of-way line of U. S. Highway No. 12, all in Section 16, Township 119, Range 35, except those portions thereof which lie westerly of a line drawn perpendicular to said south right-of-way line and which said line intersects said south right-of-way line at a point 951 feet west of the east line of the Northwest Quarter of said Section 16 as measured at right angles to said east line, containing 3.7 acres more or less.

Now Therefore, the City Council of the City of Willmar hereby determines, ordains and declares as follows:

Section 1. *Best interests of the City of Willmar and area to be annexed.* That the annexation will be to the best interests of the City of Willmar, Minnesota, and of the property affected.

Sec. 2. *Abuts on city limits.* That the property above described abuts on the city limits and is so conditioned as property to be subject to city government.

Sec. 3. *Annexation.* That the said property is hereby annexed to, and included within, the City of Willmar, Minnesota, as effectually as if it had been originally a part thereof.

Sec. 4. *Zoning.* The area above described shall be

zoned I-1 Industrial Park District.

Sec. 5. *Effective date.* This ordinance shall be filed and shall take effect and be of full force and effect from and after the filing of a copy of this ordinance with the Minnesota Municipal Commission, the Willmar Town Clerk, the Kandiyohi County Auditor, and the Secretary of State of the State of Minnesota, and from and after its passage and publication.
