ORDINANCE NO. 597

(G-11)

**An Ordinance extending the corporate limits of the City of Willmar, Minnesota, a municipal corporation of the State of Minnesota, to include certain lands not exceeding 200 acres.**

Whereas, a petition has been filed with the governing body of the City of Willmar, a municipal corporation of the State of Minnesota, by the sole owner having an interest therein, to have certain real property hereinafter described included within the limits of the City of Willmar, Minnesota, and

Whereas, it is proposed to annex by virtue hereof to the said City of Willmar said property, all of which said property is in Kandiyohi County, State of Minnesota, and

Whereas, the property to be annexed consists of approximately 20.9 acres, more or less, described as follows, to-wit:

All that part of the Southwest Quarter of the Southeast Quarter of Section 8, Township 119, Range 35, lying north of the Great Northern Railroad right-of-way, excepting therefrom the East 270.1 feet thereof.

Also the South 60 feet of the North 790 feet of the East 270.1 feet of the Southwest Quarter of the Southeast Quarter of Section 8, Township 119, Range 35, containing 20.9 acres more or less.

Now Therefore, the City Council of the City of Willmar hereby determines, ordains and declares as follows:

*Section 1. Best interest of the City of Willmar and the area to be annexed.* That the annexion will be to the best interests of the City of Willmar, Minnesota, and of the territory affected.

*Sec. 2. Land abuts city limits.* That the property above described abuts on the city limits and is so conditioned as property to be subject to city government.

*Sec. 3. Annexation.* That the property is hereby annexed to, and included within, the City of Willmar, Minnesota, as effectually as if it had originally been a part thereof.

*Sec. 4. Zoning.* The area above described shall be zoned I-2—Light Industry District.

*Sec. 5. Effective date.* This ordinance shall be filed and shall take effect and be of full force and effect from

and after the filing of said ordinance with the Minnesota Municipal Commission, the Town Clerk of Willmar Township, the County Auditor of Kandiyohi County, Minnesota, and the Secretary of State of the State of Minnesota, and from and after its passage and publication.
