ORDINANCE NO. 356

AN ORDINANCE EXTENDING THE CORPORATE LIMITS
OF THE CITY OF DETROIT LAKES, MINNESOTA
TO INCLUDE CERTAIN LANDS

THE COUNCIL OF THE CITY OF DETROIT LAKES, MINNESOTA, DOES ORDAIN:

Section 1. A petition has been filed with the governing body of the City of Detroit Lakes, Minnesota, by the owners of the following described real estate, to have such land included within the City of Detroit Lakes, Minnesota:

A tract of land located in Section Twenty-six (26), Township One Hundred Thirty-nine (139) North, Range Forty-one (41) West of the Fifth Principal Meridian, Becker County, Minnesota, containing 5.419 acres, described as follows:

Beginning at the Southwest Corner of the Northwest Quarter (NW $\frac{1}{4}$) of the Northwest Quarter (NW $\frac{1}{4}$) of said Section 26, Township 139, such point being on the center line of County-State Aid Highway No. 21, commonly referred to as Richwood Road; thence North a distance of 157 feet; thence East 250 feet; thence South a distance of 157 feet; thence West a distance of 250 feet along the South line of the Northwest Quarter of the Northwest Quarter of said Section 26, Township 139, to the point of beginning;

also,

Beginning at the Southwest Corner of the Northwest Quarter (NW $\frac{1}{4}$) of the Northwest Quarter (NW $\frac{1}{4}$) of said Section 26, Township 139, such point being on the center line of County-State Aid Highway No. 21, commonly referred to as Richwood Road; thence East a distance of 410.7 feet along the South line of the Northwest Quarter of the Northwest Quarter of said Section 26, Township 139, to a point on the center line of Knollcrest Avenue; thence South along the center line of Knollcrest Avenue a distance of 340 feet; thence West a distance of 410.7 feet to the center line of Richwood Road; thence North along the center line of Richwood Road a distance of 340 feet to the point of beginning. The described area includes the East 50 feet of Richwood Road, Nor-Lake 1st Addition, Block 1 of Nor-Lake 2nd Addition, and the West 33 feet of Knollcrest Avenue;

also,

A tract of land located in Section Twenty-six (26), Township One Hundred Thirty-nine (139) North, Range Forty-one (41) West of the Fifth Principal Meridian, Becker County, Minnesota, described as follows:

Beginning at a point 682 feet North of the Southwest Corner of the Northwest Quarter (NW $\frac{1}{4}$) of the Northwest Quarter (NW $\frac{1}{4}$) of said Section 26, Township 139, such point being on the West line of said Section 26 and on the center line of County-State Aid Road No. 21, commonly referred to as Richwood Road; thence East a distance of 250 feet; thence North and parallel to the West line of Section 26, a distance of 110 feet; thence Westerly a distance of 10 feet; thence North a distance of 124 feet; thence Westerly a distance of 240 feet to the west line of Section 26, the center line of Richwood Road; thence South along the west line of Section 26, the center line of Richwood Road, a distance of 233 feet, to the point of beginning.

Section 2. The City Council hereby determines: (1) that the annexation will be in the best interests of the City of Detroit Lakes, Minnesota, and of the territory affected; (2) that the territory described herein abuts upon the City of Detroit Lakes and is so conditioned as property to

be subjected to the city government; (3) that the area to be annexed consists of 10 houses occupied by 45 people; and (4) that the official population of the City of Detroit Lakes should include the additional 45 people.

Section 3. Therefore, the Council of the City of Detroit Lakes, Minnesota, hereby ordains and declares that the property hereinbefore described be and the same hereby is annexed to, and included in the City of Detroit Lakes, Minnesota, as effectually as if it had originally been a part thereof.

Section 4. This Ordinance shall be final and shall take effect and be in force from and after filing certified copy thereof with the Minnesota Municipal Commission, the County Auditor, the Clerk of the Town Board, and the Secretary of State, and from and after its passage and publication.
