ORDINANCE NO. 358

AN ORDINANCE EXTENDING THE CORPORATE LIMITS
OF THE CITY OF DETROIT LAKES, MINNESOTA
TO INCLUDE CERTAIN LANDS

THE COUNCIL OF THE CITY OF DETROIT LAKES, MINNESOTA, DOES ORDAIN:

Section 1. A petition has been filed with the governing body of the City of Detroit Lakes, Minnesota, by the owner of the following described real estate, to have such land included within the City of Detroit Lakes, Minnesota:

That part of the North half of the South half (N½ S½) of Section 26, Township 139 North of Range 41 West of the Fifth P. M. described as follows, to-wit:

Beginning at the intersection of the North line of Central Street and the East line of Laura Avenue according to the Plat of Mountain View Second Addition which Plat is recorded in the office of the Register of Deeds for Becker County, Minnesota; thence South 89° 59' 21" East along the North line of Central Street a distance of 210 feet; thence North 0° 55' 39" East a distance of 290 feet; thence North 89° 59' 21" West to the East line of Laura Avenue; thence South 3° 12' 9" West along the East line of Laura Avenue to the point of beginning and there terminating. Contains 1.4 acres.

Section 2. The City Council hereby determines: (1) that the annexation will be in the best interests of the City of Detroit Lakes, Minnesota, and of the territory affected; and, (2) that the territory described herein abuts upon the City of Detroit Lakes and is so conditioned as property to be subjected to the city government.

Section 3. Therefore, the Council of the City of Detroit Lakes, Minnesota, hereby ordains and declares that the property hereinbefore described be and the same hereby is annexed to, and included in the City of Detroit Lakes, Minnesota, as effectually as if it had originally been a part thereof.

Section 4. This Ordinance shall be final and shall take effect and be in force from and after filing certified copy thereof with the Minnesota Municipal Commission, the County Auditor, the Secretary of State, and the Clerk of the Town Board, and from and after its passage and publication.
