

PETITION FOR ANNEXATION

TO: Village Council  
Village of Mountain Lake, Minnesota

The undersigned, being all \*\*\*\*\* of the property-owners  
and residents of the following-described tract, to-wit:

Tract located in the Southwest Quarter (SW $\frac{1}{4}$ ) of the Southwest Quarter (SW $\frac{1}{4}$ ), of Section Twenty-Eight (28), Township One Hundred Six (106), North, Range Thirty-four (34), West, described as follows: Beginning at a point 1268.5 feet west and 250 feet north of the southeast corner of the Southwest Quarter (SW $\frac{1}{4}$ ) of said Section, thence North 38.5 degrees west a distance of 1006.5 feet, thence at right angles southerly a distance of 206 feet, more or less, to the northerly right-of-way line of County Aid Road No. 9 (C.A.R.No.9), thence southeasterly along the northerly line of County-aid road a distance of 900 feet to a point 250 feet north of the south line of said Section, thence East in a straight line to point of beginning. (Cottonwood County, Minnesota)

Excepting therefrom the following-described tract: Beginning at a point 1445.5 feet West and 283 feet North of the Southeast corner of the Southwest Quarter of Section 28, Township 106, Range 34, thence North 38.5 degrees West a distance of 169 feet and 5 inches, thence at right angle in a Westerly direction a distance of 150 feet to the Northerly right-of-way line of County Aid Road No. 9, thence at right angle in a Southeasterly direction along the Northerly line of said right-of-way a distance of 87 feet and 9 inches, thence East on a straight line a distance of 170 feet and 9 inches, to the point of beginning. ORDINANCE NO. 119

AN ORDINANCE RELATING TO ANNEXATION

The Village Council of Mountain Lake, Minnesota, ordains:

Section 1. Annexed Territory

The following-described territory is hereby annexed to the Village of Mountain Lake, County of Cottonwood, and State of Minnesota, to-wit:

Tract located in the Southwest Quarter (SW $\frac{1}{4}$ ) of the Southwest Quarter (SW $\frac{1}{4}$ ), of Section Twenty-Eight (28), Township One Hundred-Six (106), North, Range Thirty-Four (34), West, described as follows: Beginning at a point 1368.5 feet west and 250 feet north of the Southeast corner of the Southwest Quarter (SW $\frac{1}{4}$ ) of said Section; thence North 38.5 degrees west a distance of 1006.5 feet; thence at right angles southerly a distance of 206 feet, more or less, to the northerly right-of-way line of County Aid Road No. 9 (C.A.R. No. 9), thence southeasterly along the northerly line of County-Aid road a distance of 900 feet to a point 250 feet north of the south line of said Section; thence East in a straight line to point of beginning. (Cottonwood County, Minnesota); excepting therefrom such portion thereof as is presently situated within the corporate limits of the Village of Mountain Lake, Cottonwood County, Minnesota..

Section 2. Effective Date

This Ordinance becomes effective on the date of its publication.
