

ORDINANCE NO. 547

AN ORDINANCE DECLARING CERTAIN PLATTED LAND  
TO BE ANNEXED TO THE CITY OF NORTH MANKATO  
AND PROVIDING ZONING THEREFOR.

The Common Council of the City of North Mankato, Minnesota, does  
ordain as follows:

Sec. 1. The Northwest Quarter of the Southeast Quarter of Section 2-108-27,  
except for that portion lying Westerly of the State Aid Highway No. 13 now  
located across said tract, the same constituting 39 acres, more or less, and  
any and all streets, highways or other public rights of way within and adjacent  
to said described land, is hereby annexed and declared to be a part of the  
City of North Mankato and to be included in the corporate limits thereof.

Sec. 2. The above-described land be and hereby is zoned I-2  
General Industry, pursuant to the Zoning Ordinance of the  
City of North Mankato.

Sec. 3. This Ordinance shall take effect from and after its date of  
passage and publication.
