At a meeting of the Board of Directors of the Auburn Iron Co. duly called and held on the <u>Shired</u> day of <u>April</u>, A. D., 1894, the following Preamble and Resolutions were unanimously adopted, to-wit:

RESOLVED FURTHER: That the real estate of this Company hereinafter described be, and the same is, hereby set apart and designated under the direction and provisions of the said Act of the Legislature as that portion of this Company's property, in and upon which real estate its business of mining Iron Ore is at the present time carried on, and which is connected therewith and set apart for such business, to-wit: NW\$\frac{1}{2}\$ of Section 20, and the W\$\frac{1}{2}\$ of NE\$\frac{1}{2}\$ of Section 20, and the Fourth (4th) Principal Meridian, in St. Louis County, State of Minnesota.

RESOLVED BURTHER: That in order that this Company may be bound by the provisions and entitled to the benefits of said Act, the Secretary of this Company be, and the same is, hereby authorized and directed to prepare two copies of these resolutions and have the

same each duly certified under the signatures of the President and Secretary, and the Corporate seal of the Company, and file one copy of the same with the Secretary of State for Minnesota, and then procure the Secretary's endorsement on the other copy, stating that a like one has been filed in his office.
