Pursuant to Minnesota Statutes 16.125, 16.13, 16.135 and Minnesota Laws, 1973, Chapter 507, Section 39, the following administrative reorganization is hereby made.

These positions and appropriation transfers relate to changes in state government affecting the Department of Administration in establishment of a Department of Personnel.

All functions and responsibilities, as may be referenced by statute, of the State Labor Negotiator are hereby transferred from the Department of Administration, Ancillary Services Program, to the Department of Personnel.

The legislative complement of the Department of Personnel is hereby increased by three full time positions.




