REORGANIZATION ORDER NUMBER 36

Pursuant to Minnesota Statutes 16.125, 16.13, and 16.135 the following administrative reorganization is hereby made.

All functions, duties, and responsibilities, as may be referenced by statute, of the Department of Public Welfare, Crippled Children Services Activity, are hereby transferred to the Department of Health.

All personnel as of November 28, 1973, at their current salary with all accrued benefits, of the Department of Public Welfare, Crippled Children Services Section, are hereby transferred to the Department of Health.

All appropriations, allotments, requisitions, encumbrances, unallotted balance, and the allotted free balance of the Department of Public Welfare's U.S. Aid to Crippled Children account (50023:01-30) for fiscal year 1974 are hereby transferred to the Department of Health.

All allotments, requisitions, encumbrances, unallotted balances, and the allotted free balance of the Department of Public Welfare's Crippled Children Services account (50023:03-10) for fiscal year 1974 are hereby transferred to the Department of Health.

The Department of Public Welfare's state appropriation for Crippled Children Services for fiscal year 1975 is also transferred to the Department of Health.

The Commissioner of Finance is hereby authorized to complete these transfers.

This order is effective November 28, 1973.
