ORDINANCE NO. 93

AN ORDINANCE ANMEXING LANDS TO THE VILLAGE OF ZUMBROTA

The Village Council of Zumbrota ordains that the land area contained within the following described boundaries is hereby annexed to and incorporated within the Village of Zumbrota, to-wit:

That part of the Northwest Quarter (NW 1/4) of Section 6, Township 109 North, Range 15 West, described as follows:

Beginning at the Northwest corner of the East Half (E 1/2) of the Northwest Quarter (NW 1/4) Section 6, Township 109 North, Range 15 West. thence South 01° 05' 23" East 799.45 feet to North right-or-way line U. S. Minn. T.H. No. 52, thence North 51° 12' 49" West on said North right-of-way line 218.14 feet, thence deflect to the right on said North right-of-way line 382.44 feet on 1045.93 feet radius curve, delta angle equals 20° 57', chord bearing and length North 40° 44'23" West 380.31 feet, thence on North right-of-way tangent North 30° 15' 53" West 257.60 feet, thence North 165.56 feet to North line said Northwest Quarter (NW 1/4) of Section 6, thence south 88° 32' 40" East on said North line of the Northwest Quarter (NW 1/4) 533.03 feet to point of beginning, containing 6.63791 acres, more or less. For purposes of this description the East line of the Southeast Quarter (SE 1/4) of Section 36, Township 110 North, Range 16 West, is assumed True North.
