EXTRACT OF MINUTES OF A SPECIAL MEETING OF THE VILLAGE COUNCIL OF THE VILLAGE OF RICHMOND, STEARNS COUNTY, MINNESOTA

A special meeting of the Village Council of the Village of Richmond, Stearns County, Minnesota, was held at the Village Hall in said Village on Monday, November 12, 1973, commencing at 9:00 P.M.

The following members were present: and the following were absent:

Village Attorney, J. J. Willenbring, reported that he had served notice of petition for annexation of land to the village by mailing copies of the petition on September 5, 1973, to the Stearns County Board of Commissioners, addressed to A. B. Hinnenkamp; Minnesota Municipal Commission; and the Munson Township Clerk, addressed to Mr. Howard Reitmeier, and that no objection to the petition had been filed by any of said bodies, with either the Mayor, Clerk or the Village Attorney, and that the Village Attorney had received acknowledgment from the Minnesota Municipal Commission stating the petition was in order.

Thereupon, Councilman Ray Wenner introduced the following resolution and moved its adoption:

RESOLUTION ADOPTING AN ORDINANCE EXTENDING THE VILLAGE OF RICHMOND TO INCLUDE UNPLATTED LANDS ABUTTING UPON THE VILLAGE LIMITS AND ASSIGNING ZONING CLASSIFICATIONS.

BE IT RESOLVED by the Village Council of the Village of Richmond, Minnesota, the following ordinance is hereby adopted as Ordinance No. 73.20, the Mayor and Clerk are hereby authorized to sign the same, and the Clerk is directed to make arrangements for publication of the same in the STEARNS-MORRISON ENTERPRISE, to-wit:

ORDINANCE NO. 73.20

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF RICHMOND TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LANDS NOT EXCEEDING 200 ACRES IN AREA ABUTTING THE VILLAGE LIMITS AND ASSIGNING ZONING CLASSIFICATIONS.

WHEREAS, a certain petition, dated August 27, 1973; requesting annexation of the territory hereinafter described was duly presented to the council on the 30th day of August, 1973; and

WHEREAS, the quantity of land embraced in the area described in the petition and bounded as described is approximately 12.77 acres more or less of unplatted land, no part of which is included within the limits of an incorporated city, village, or borough; and

WHEREAS, the petition was signed by all the owners of said land; and

WHEREAS, no objections to the annexation have been received from the Town Board of Munson Township, the Stearns County Board of Commissioners, or the Minnesota Municipal Commission, said bodies having due notice as provided by statute, and more than sixty (60) days having elapsed since said notice was provided; and

WHEREAS, the land described in the petition abuts the village limits at the east boundary thereof,

NOW THEREFORE, THE COUNCIL OF THE VILLAGE OF RICHMOND, MINNESOTA, ORDAINS:

Section 1. The Village Council hereby determines: (1) that the annexation will be in the best interests of the village and of the territory affected; (2) that the

territory described herein abuts upon the village limits and is about to become urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village, or borough.

Section 2. Territory Annexed. The corporate limits of the Village of Richmond are hereby extended to include the unplatted land described as follows, and the same is hereby annexed to and included within the village as effectually as if it had originally been a part thereof:

All of Lot One (1) lying North of the Great Northern Railway Company's Right-of-way in Section Twenty-four (24), Township One Hundred Twenty-three (123), of Range Thirty-one (31), less the West Forty-nine (49) feet South of the Richmond Cold Spring State road, containing 18.77 acres more or less, according to the government survey thereof. LESS AND EXCEPT That part of Government Lot One (1), Section Twenty-four (24), Township One Hundred Twenty-three (123), Range Thirty-one West (31), commencing at the point where the West line of said Government Lot One (1) intersects the Northerly right-of-way line of Great Northern Railroad and running thence North 820 12' East along said right-of-way line for a distance of 49.46' to the point of beginning continuing thence North 820 12' East along said Northerly rightof-way line for a distance of 923.94' to the center of a public road; running thence North 660 08' West along center of said road for a distance of 900.2'; running thence North 60° 46' West along center of said road for a distance of 105.9' to a point which is directly North of the point of beginning; and running thence South 541.7' to the point of beginning and there terminating. Said tract containing six acres more or less. Said tract containing 12.77 acres more or less.

Section 3. Zoning Classification. The area annexed as described in Section 2 of this ordinance is hereby classified as Light Industrial as defined in the Village of Richmond Zoning Ordinance and the Zoning Administrator is hereby directed to amend the Official Zoning Map to display the annexed area and the zoning classification.

Section 4. Filing. The Village Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, the Stearns County Auditor, and the Clerk of the Township of Munson.

Section 5. Effective Date. This ordinance takes effect upon its passage, publication, and the filing of the certified copies as directed in Section 4.

The motion for the adoption of the foregoing resolution was duly seconded by Councilman Gregor Thomes, and upon vote being taken thereon the following voted in favor thereof: passed unanimously and the following voted against the same: none whereupon said resolution was declared duly passed and adopted.
